The Chief Controller of Stamps Karachi (Pakistan Post) invites sealed tender for the supply of Drinking Water during the fiscal year 2018-19 and extendable for one year from reputed Firms who have registration with the department of Income Tax/General Sales Tax. The tender forms along with details of items required and terms & conditions can be obtained from the office of the Chief Controller of Stamps Plot St. 3 Sector 26 Korangi Industrial Area Karachi during office hours on payment of Rs. 1000/- in shape of the unclassified Post office receipt ACG – 67 PO till 29-08-2018. The tender forms must be dropped in the tender box up to 11:00 AM on 29-08-2018, which will be opened on the same day at 11:30PM. The earnest money @ 2% (Two percent) of the total bid value (refundable) in shape of pay order or ACG – 67 PO (unclassified Post office receipt) in favor of Chief Controller of Stamps Karachi has to be accompanied with the tender form. All relevant taxes will be deducted according to the Government rules. The competent authority may reject all the bids or proposal at any time prior to the acceptance of a bid or proposal with intimation the ground of rejection. However, justifications of that ground will not be communicated. Work order will be issued subject to the extent of availability of funds.

3. All Government Taxes will be deducted as per law/rules.
4. The bidder should enclose a copy each of NTN, Sales Tax Registration Certificates and CNIC of the proprietor
5. Incomplete tender will not be accepted in any case.
6. The undersigned reserves the right to cancel any or all bids either in whole or in part as per rule, subject to availability of funds.
7. Successful bidders have to supply the water as per order within the three hours.
8. The bids shall remain valid for the work orders to be issued up to 30-06-2019 and extendable for one year.
