Government of Pakistan, National History & Literary Heritage Division through Resident Engineer/Project Director, Quaid-i-Azam Mazar Management Board intends to invite sealed bids from interested Bidders Meeting the eligibility criteria of “**Public Procurement Regulatory Authority (PPRA) Rules 2004** for “**Installation and Operation of Municipal Waste Water Treatment Plant at Peripheral Area of Mazar-e-Quaid, Karachi**”.

1. Interested firms having relevant experience can purchase tender documents from office of the undersigned on submission of written application with a pay order of Rs. 5000/- (Non-Refundable) in favor of Resident Engineer, Quaid-i-Azam Mazar Management Board with effect from **06-02-2018** to **20-02-2018**. Tender documents can also be downloaded from www.ppra.org.pk & www.qmmb.gov.pk.
2. Tender documents prepared in accordance with the instructions in the bidding documents must reach on or before 20-02-2018 at 11:30am at the **Office of Resident Engineer/Project Director, Quaid-e-Azam Mazar Management Board, Adjacent Mazar-e-Quaid, Corridor-III, Karachi**. Technical Proposals shall be opened on the same date at 12:00 noon in the presence of bidders who wish to attend. Bidding procedure will be carried out in accordance with 36(b) of PPRA rules 2004.
3. If due to unavoidable circumstances, the undersigned is out of headquarter, or in case of public holiday declared by Government, the tender shall be opened on next working day.
4. Apart from other requirement as requested in bidding documents following eligibility conditions for intending participants are as under:
 - a. Valid registration certificate in the Category C-5 or above and disciplines CE-01, CE-04, CE-09, CE-10, EE-04, ME-03, ME-06 with Pakistan Engineering Council for the year 2018
 - b. Valid registration certificate from income tax authority (NTN) & Sindh Revenue Board (SRB); and
 - c. Attach details of litigation/black listing of the company. (Attach all certificates of litigation/blacklisting or incase there is no such case attach affidavit of not black listing on a stamp paper of 100 Rs. only. Not doing so will result in rejection of tender).
 - d. Full name of the firm along with organizational structure and permanent address with telephone number, fax number and e-mail.
 - e. Details of works executed by the contractors in the past five (05) years indicating scope of works, estimated cost and time taken for completion duly certified by the concerned officials.
 - f. List of location of equipment, transport and machinery available with the contractor for this job.
 - g. Affidavit that the contractor has neither been blacklisted by any agency nor involved in any subversive activities.
 - h. Bio-data of the technical staff permanently employed and available with the firm/contractor.
 - i. List of cases entered into arbitration/litigation. If not involved, then affidavit to the effect that the firm/contractor was not involved in any litigation, no work was rescinded in the past.
 - j. List of works where penalty is involved, if any.
 - k. Income Tax returns of last three years duly certified/verified.
 - l. Any additional information the applicant may like to furnish in support of its papers.
5. If firm/partner is involved in partnership deed, then complete details/instructions and power of attorney be submitted with affidavit by the proprietor.
6. As per the PPRA rules 33(1), 2004, the competent authority reserves the right to reject any or all tenders/bid proposals at any time prior to the acceptance of a bid/proposal. The advertisement is also available on PPRA website at www.ppra.org.gov.pk.
