CIR Internet Connectivity at EOBI Head Office, Karachi and DR-Site, Lahore

Employees' Old-Age Benefits Institution is an autonomous organization of Government of Pakistan, established in 1976 to provide benefits to the register workers of industrial, commercial and other organizations. It intends to promote its benefits among stakeholders and encourage employers and employees with EOBI for availing the benefits.

Employees' Old-Age Benefits Institution (EOBI) invites applications from technically competent and financially strong companies dealing in Internet Services, 32Mbps CIR Internet connectivity at EOBI Head Office, Karachi and 2Mbps at DR-Site, Lahore (**for two years, renewable for further three years** with same terms and conditions). The bidding is being carried out under PPRA Rule 36(b) of Public Procurement Rules 2004.

SCOPE OF WORK

- 32 Mbps CIR Internet Connectivity on Fiber with backup on Fiber from separate Hubs for EOBI Head Office, Karachi.
- Allocation of /28 Public IP address pool at Head Office, Karachi and /29 Public IP address pool at DR-Site, Lahore
- 2 Mbps CIR Internet Connectivity on Fiber with backup on Fiber from separate Hubs for EOBI DR-Site located at Lahore with allocation to increase of bandwidth on demand.

Internet Companies may submit the proposals (Technical and Financial) with the validity of 180 days along with 2% earnest money. The last date of submission of the bid is **03/07/2018** at 11:30 AM. The technical bids will be opened on the same date at 12:00 Noon by the purchase committee at Board Room, EOBI Head Office, 190/1/B, Block-2, P.E.C.H.S., Karachi.
