3. Firm participating in bid must be registered with relevant registering Authorities, along with proof (i.e. Form "C", Certificate of Incorporation etc).
4. Conditional / Ambiguous/ with cuttings / overwritten / incomplete and handwritten tenders shall not be accepted.
5. Single stage 02 envelope procedure (separate envelope for technical and financial proposals) will be adopted as per GB PPRA Rules 2022 clause 39(b).
6. The procuring agency may reject all bids/proposals at any time prior to acceptance of a bid on any ground but is not bound to justify those grounds.
7. Bids are to be dropped in the office of the "Deputy Director (Operation) Excise and Taxation Department Jutial Complex Gilgit" on the given date and time.
