1. The contractors are required to submit application along with documents as per term & condition on the original pad of the contractor/firm along with bid security in the shape of deposit at call from any schedule bank functioning at Islamabad/Rawalpindi in favor of the Executive Engineer, Central Civil Division-II Pak PWD Islamabad upto **01.04.2024** during office hours.
2. No tender will be sold/received by post/ telephonically/ e-mail or on date of opening of tender.
3. The applications should be accompanied with attested copies of CNIC, valid enlistment with Pakistan Engineering Council, certificate showing the registration with Income Tax department (ATL) and partnership deed in case of partnership or affidavit declaring himself sole proprietor of the firm, whichever is applicable
4. Tender, will only, be issued to the owner of the firm or his authorized representative having legal power of attorney
5. An affidavit on judicial paper worth Rs 50 to the effect that the contractor/ firm is not in any dispute/ litigation with any government department is a prerequisite for issuance of tenders.
6. The tenders shall not be issued to those contractors who do not fulfill requirements mentioned in the SRO-2004 regarding Categorization, Classification & Enlistment of Contractors Rules.
