3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration certificate. Contractors not registered with PEC are ineligible to apply.

4. Firms/Contractors who are enlisted with MES in Category E & above and also having experience of this type should only apply.

5. Contractors who desire may be present at the time of opening of tenders.


6. The accepting officer reserve the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
