- Pay Order/Demand Draft amounting to Rs.25,000/- (Rupees Twenty Five Thousand Only) in favour of **National Highway Authority/Road Maintenance Account (RMA)** for each vehicle will be deposited by the participants alongwith copy of valid CNIC as Expression of Interest/Token Money without depositing such PO/DD no person shall be allowed to participate in public auction.
- Successful/Highest bidder(s) shall have to deposit 25% of the highest bid amount at the spot for each vehicle as earnest money (Non Refundable), failing which the bid shall be rejected, token money of the bidder shall be **forfeited** and vehicle shall be presented again for auction at the end.
- The Successful/highest bidder shall deposit the remaining bid amount within 10 (Ten days) after approval of the bid by competent authority, otherwise, 5% of bid amount shall be charged as ground rent up to period of 15 days and thereafter the whole amount will be forfeited.
- Public open auction will be held on **May 13, 2024 at 1000 Hours** at NHA Karachi, by the Respective Committee in the presence of Eligible Bidders, who will also provide the copy of valid CNIC, complete address, email and telephone/mobile/cell numbers.
- Detail of Registration Books & Excise Return File available/not available is mentioned above and same will be auctioned subject to willingness of bidders to arrange the same at their end.

 

8. Remaining /Outstanding Token Tax against the vehicles etc will be paid by the successful bidder.
9. Government Tax(s) (whatsoever admissible) will be charged as per prevailing Federal Government Rules, besides Bid Price separately.
10. The Vehicles shall be handed over to successful/highest bidder after full payment, depositing of Taxes in FBR and after transfer of ownership from the concerned ETO/Motor Regional Authority.
11. NHA Reserve the right to accept or reject any or all bids and to add or withdraw any vehicle before Public auction.
12. In case of any dispute the decision of Auction Committee shall be final and not challengeable in any court of Law.
13. Queries (if any) can be cleared at the spot thereafter no objection shall be entertained and decision of Auction Committee shall be final.
