- 5. The issuance of work order shall be subject to approval from Board.
- 6. The validity of tender rates shall be up to 180 days as per PPRA/PEC Rules.

- The rates should be quoted in Pakistani rupees. A lump sum amount or per SQFT rate shall be quoted
 of the entire job.
