3. Pay Order/Demand Draft amounting to Rs. 50,000/-(Rupees Fifty Thousand only) **in favor of General Manager** (**Punjab-South**) **NHA**, **Retention Money Account** for Vehicles will be deposited by the participants along with copy of valid CNIC, as Expression of Interest/token money, without depositing such PO/DD no person shall be allowed to participate in public auction.

4. Successful/highest bidder(s) shall have to deposit 25% of the highest bid amount at the spot for each vehicle as earnest money **(Non Refundable)**, failing which the bid shall be rejected, token money of the bidder shall be **forfeited** and vehicle shall be presented again for auction at the end.

5. The successful/highest bidder shall deposit the remaining bid amount within 10 (Ten) days after approval of the bid by competent authority, otherwise, 5% of bid amount shall be charged as ground rent up to period of 15 days and thereafter the whole amount will be forfeited.

6. Public auction will be held on **21-05-2024** at **1130** hours at NHA Regional Office (Punjab-South) Chowk Nag Shah, Multan by the Respective Committee in the presence of Eligible Bidders. Bidders will provide copy of valid CNIC, complete address, email and telephone /mobile cell numbers.

7. Original Excise File of Vehicles at serial No 01 & 02 are not available and same will be auctioned subject to willingness of bidders to arrange the same at their own end.

8. Remaining /Outstanding Token Tax etc will be paid by the successful bidder.

9. Government Tax (s) (whatsoever admissible) will be charged as per prevailing Federal Government Rules, besides Bid Price separately.

10. The vehicles shall be handed over to successful/highest bidder after full payment, depositing of Taxes in FBR and after transfer of ownership from the concerned ETO/Motor Registration Authority.

11. NHA Reserve the right to accept or reject any or all bids and to add or withdraw any vehicle before Public auction.

12. In case of any dispute the decision of Auction Committee shall be final and not challengeable in any court of Law.
