## **TENDER NOTICE**

Two sealed envelop having clearly marked as Technical and Financial Proposal" are invited from reputed firms for supply of Awareness material in Ministry of Narcotics Control (MNC) Islamabad, at 6<sup>th</sup> Floor, Kohsar Block, Constitution Avenue, Islamabad. - Firms having documentary proof of successfully completed works of similar or higher quantum shall be eligible to participate in the bidding.
- Complete profile of firms may also be attached with Technical bids.
- 3. Specifications and model numbers of items shall be strictly followed and no items shall be accepted which is not according to the detailed specifications provided by this office.
- 4. Bids must be submitted along with CDR@ Rs.50,000/-.
- 5. all applicable taxes, levied by the Government shall be deducted from the quoted prices. All prices should be quoted inclusive of all applicable taxes in Pak Rupees. The Bidders are required to fill in the unit price/rate against each item in the bill of quantities in Pak Rupees in numerals and words both.
- 6. Technical & Financial bids should be completed in all respects and reach the office to the undersigned on or before, 21-05-2024 which shall be opened on same day at 1200 hrs in the Committee Room of MNC in the presence of authorized representatives of firms who choose to attend.
- 7. The successful bidders shall be bound to complete the assignment within 07 days from the date of issuance of work order.
- All prices should be valid for till 30<sup>th</sup> June, 2024. Withdrawal or any modification of the original offer within the validity period shall entitle MNC Islamabad to forfeit the earnest money and/or impose

ban on such vendor from future participation in MNC tenders/works.

- The competent authority reserves the right to reject any or all offers without assigning any reasons.
- It shall be the responsibility of the supplier to satisfactorily complete the job as per work order, which includes delivery, and MNC's acceptance/inspection thereof.
- **11.** The earnest money will be released after closing of financial year **2023-2024.**
- Items being ordered should be branded/new and the firm all should be adhere to provide the supply as per laid down specifications.
- 13. The firm will not be considered if:-
  - Technical and financial bids are received in single envelope.

  - d. The offer is ambiguous/conditional.
  - e. The firm is black listed by any Government Office.
  - f. The offer is received by telephone/telex/fax/telegram.
  - g. Any unsigned/ambiguous erasing, cutting/overwriting etc is made.

# **DOUBT IN TENDER DOCUMENTS**

1. Any bidder who may have any doubt or questions as to the true meaning of any part of the tender documents should deliver a written request to the Section Officer (General) MNC for any clarification or answer thereof, prior to the date set for opening of the Tenders. Any explanations, revision, additions or deletions to the tender documents will be made only by formal addendum, fully signed and issued by the MNC, and mailed or delivered to each bidder, who has received a set or tender documents, such addendum will become an integral part of the tender document and receipt thereof must be acknowledged by return of the form

issued with the addendum. Each addendum shall be signed by the bidder. MNC shall not be responsible nor bound by any explanations, revisions, additions or deletions to the tender documents except those contained in the formal addendum signed and issued by the MNC.

#### Part B:

# **Evaluation Criteria**

- 1. The bidders are required to submit technical and financial proposals in separate envelops simultaneously on the date of bids submission. The envelopes should be clearly marked as "Technical Proposal" and Financial Proposal" respectively. The earnest money should be included in the Financial Proposal and no reference what so ever regarding financial proposal and earnest money should be given in the technical proposal. The tender shall be single stage two envelops bid. The technical proposal will be evaluated on the basis of information provided on the matrix and the recommendation of the "Technical Evaluation Committee" shall deem final.
- The technical proposal shall be opened first and the financial proposals of qualified bidders only as per criteria explained above shall be opened later. The date and time for which will be indicted separately.
- 3. The rates quoted by the firms must include following:
  - a. The rates must be quoted in accordance with the detailed specifications, proposed quantities. The rates should be quoted basis in Pak Rs. inclusive of all taxes.
  - b. Delivery date.
  - c. Validity period of the quoted price (30th June, 2024).
  - d. Any other information deemed necessary.
- 4. The successfully bidder will be asked to provide sample for the approval of the technical committee. The sample will be judged by a technical committee for dimensions, texture, color, finishes, material, strength, workmanship etc.
- The contractor/bidder whose bid have been determined to be substantially responsive technically and to the conditions of tender document and has offered the lowest evaluated price will be awarded the work/contract in a non-discriminatory.

### Part C:

# AWARD OF WORK

- MNC will award the work to the bidder whose bid has been determined to be substantially responsive to the tender documents and who has offered the lowest bid price and conformed to the specification and whose sample has been approved by the Technical committee.
- The earnest money of the successful bidder will be retained with MNC until completion of works, removal of remedies and defects plus period of maintenance of 6 months from the date of issuance of Certificate of the Completion of Work, the earnest money of the unsuccessful bidders will be released once decision of award of work is final.

# **DELIVERY OF AWARENESS MATERAIL**

- The Bidder shall provide one (1) sample if required of each Awareness Material at site and get formal approval within ten 10 days from the date of issuance of Letter of Intent. The sample will remain in custody of MNC and comparison would be made with the delivered items, when due. Sample will be supplied by the bidders to the MNC Islamabad at their own risk and cost.
- Once the work order is issued, the bidder shall arrange inspection
  of all the Awareness Material by the authorized officials of MNC
  before supply/finishing, if required, bidder shall be bound to do the
  final finishing work at the premises of the MNC.
- Delivery of items will be free of charge at the official site during the office hours accompanied with the signed copy of the delivery challan. The delivery of items shall be made on three (03) days prior notice to the authorized officials.

# TIME PERIOD FOR THE DELIVERY OF AWARENESS MATERAIL

- 1. The time period for completion of items will be three (07) days from the date of issuance of the Letter of Intent (LOI).
- 2. In case of delay in delivery of items, 2.5% of the total amount of the order will be charged as penalty per week, up to a maximum of 10% of the total bid price. Failure to complete the supplies within 30 days will be make the work order eligible for termination with no compensation due to be paid to the supplier and any supplies already made/earnest money submitted will be forfeited.

# **PAYMENT OF AWARENESS MATERAIL**

- The payment will be made on bill GST invoice. The Contractor shall submit bill once 100% of the work order of the items have been completed.
