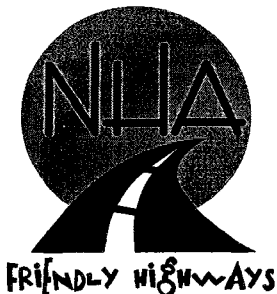

Consultancy Services for Review of Preliminary Design alongwith Alignment Optimization (if required), Traffic Studies, Commercial Feasibility Study and Bid Evaluation/ Bid Comparative Analysis for Hyderabad - Sukkur Motorway Project on Built-Operate-Transfer (BOT) Basis under Public Private Partnership (PPP) Arrangement

1. National Highway Authority (NHA) intends to engage a Consultant/ Engineering Organization/ Firm to carry out **Review of Preliminary Design alongwith Alignment Optimization (if required), Traffic Studies, Commercial Feasibility Study and Bid Evaluation/ Bid Comparative Analysis for Hyderabad - Sukkur Motorway Project on BOT Basis under PPP Arrangement.**

Proposals are invited from reputable Consultants/ Engineering Organizations/ Firms: (i) Registered with Income Tax and Sales Tax Departments and who are on Active Tax Payers list of the Federal Board of Revenue, and (ii) having PEC registration in relevant field with relevant experience as mentioned in the RFP.
3. Interested firms may download the Request for Proposal (RFP) document from NHA website i.e. (www.nha.gov.pk) free of cost.
4. Pre-Proposal Conference will be held on **17th October, 2018 at 1100 hours** in the NHA Auditorium (HQ) Islamabad.

The Proposals complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on **31st October, 2018 at 1130 hours** in NHA Auditorium, 27, Mauve Area, G-9/1, Islamabad and be clearly marked "*Consultancy Services for Hyderabad - Sukkur Motorway Project on BOT Basis under PPP Arrangement*".
6. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of the technically qualified firms shall be opened after finalization of technical evaluation. Other details are provided in the RFP.
7. All the applicable Federal, Provincial & Local taxes (including GST) must be considered while preparing the financial proposals. All these taxes except GST are required to be built-in in the quoted rates and not be mentioned separately.
