for Renovation & Enlargement of Consular Area
Embassy of Pakistan Riyadh

The Embassy of Pakistan in Riyadh invites proposals from the construction firms/companies, registered with the government of Saudi Arabia and having the authorization to work in Riyadh diplomatic area. Furthermore, they should be having a minimum of 5 years experience. The firm would be required to:

1. Undertake the enlargements/renovation work at the Embassy premises as per drawings and BOQs attached in the tender documents.
 2. Submit technical and financial bids related to the work separately. Both bids should be enclosed in a single envelope and sent to the Embassy on the address given in the tender documents.
 3. Bidder / Contractor should have similar work experience (within KSA) which should be reflected in the technical bid.
 4. Bidder / Contractor should have proper material supply chain for the material which will be required for the execution of the works.
 5. Bidder / Contractor have to complete all work as per given schedule in the bidding documents.
 6. Bidder / Contractor should have all Saudi Government certificates to perform the job.
2. The method of selection, depending on compliance to the specifications / requirements, will be Quality and Cost Based. Expression of Interest documents containing detailed terms and conditions can be obtained, by payment of processing fees of SR 300/-, from the following address:
