**AGE LIMIT.**

- a. Candidates belonging to scheduled castes, Buddhist Community, recognized tribes of the Tribal Areas, Azad Kashmir and Northern Areas for all posts under the Federal Government age shall be relaxed by **03** years.
- b. In case of Ex-serviceman the upper age limit is relaxable for **15** years or the number of years actually served in the Armed Forces of Pakistan which ever is less.
- c. In case of widow, son or daughter of deceased Railway employee who dies during service shall be relaxed by **05** years.
