NOTICE INVITING TENDER FOR HIRING OF SECURITY SERVICES AND TRAINED FIRE FIGHTERS SECURITY GUARDS

Trading Corporation of Pakistan (Pvt.) Ltd., (TCP'), Karachi invites bids from reputable Security Companies, which are registered with Federal and Provincial tax authorities and active on tax payer list and also registered with relevant Home Departments/Ministry of Interior to provide Security Services, including posting of Security Guards Personnel at different godowns/warehouses/offices locations, subject to terms & conditions specified in the Tender Document.

- Bidding will be conducted under Rule 36(b) of the Public Procurement Rules, 2004 i.e. Single Stage Two Envelope procedure. Security Company shall also ensure the availability of trained fire fighting security guards as and when required by TCP's for deployment at TCP's storage godown including any private godown hired by TCP.
- Bid shall only be received from those firms who are registered with PPRA for e-Procurement on EPADS for Tendering in TCP.
- Interested and eligible Security Companies may submit their offers/bids comprising 4. Technical Proposal and Financial Proposal, to be submitted on E-PADS by 09th May 2024, at 11:00 hrs. Technical proposal will be opened on the same day by 1130 hours in the TCP's Board Room, in presence of bidders or their authorized representatives who may wish to be present.
- Bids must be supported with Bid Money as required in the Tender Documents. The Original Bid Money must reach to this office prior to closing time i.e. 1100 hrs on 09th May, 2024 and copy must be attached with the Technical /Financial proposals.
- The tender documents can be downloaded from TCP's website www.tcp.gov.pk, 6. PPRA's website www.ppra.org.pk.
- The Interested parties who have not fulfilled their contractual obligation with TCP 7. previously shall not be eligible to participate in the Bids, unless they clear their dues along with penalties or fulfill their contractual obligations in services with TCP, as the case may be, before tender opening date. Furthermore, the Security Company against whom blacklisting process has been initiated or they have been blacklisted by TCP is not eligible to participate. Detailed requirements are indicated in the Tender Document containing tender terms & conditions.

TCP reserves the right to reject any or all bids at any time prior to their accellance as per PPRA Rule.

TENDER DOCUMENT TERMS & CONDITIONS FOR HIRING OF SECURITY GUARDS AND TRAINED FIREFIGHTING SECURITY GUARDS

1. INSTRUCTIONS TO THE BIDDERS:

- 1.1 Trading Corporation of Pakistan (Pvt.) Ltd is a private limited company incorporated under the companies Act, 1913 (now companies Act, 2017) and operating under the administrative control of Ministry of Commerce, Government of Pakistan, invites bids for a period of one year further extendable as per agreement from reputable security companies which are registered with relevant Home Department/ Ministry of Interior to provide security services, including posting of security guards at different locations of Karachi, Multan and Islamabad. The bidders must be registered with Federal and Provincial tax authorities for Income Tax and Sales Tax and have active status on tax payer list.
- 1.2 Interested and eligible Security Companies may submit their offers/bids comprising Technical Proposal and Financial Proposal, to be submitted on E-PADS by 09th May 2024, at 11:00 hrs. Technical proposal will be opened on the same day by 1130 hours in the TCP's Board Room, in presence of bidders or their authorized representatives who may wish to be present. After evaluation and approval of Technical Proposals, TCP shall open the Financial Proposals of technically responsive bidders only.
- 1.3 Bidding will be conducted under Rule 36(b) of the Public Procurement Rules, 2004, i.e. Single Stage Two Envelope procedure. Security Company shall also ensure the availability of trained fire fighting security guards as and when required by TCP's for deployment at TCP's storage godown including any private godown hired by TCP.
- 1.4 The Interested parties who have not fulfilled their contractual obligation with TCP previously shall not be eligible to participate in the Bids, unless they clear their dues along with penalties or fulfill their contractual obligations in services with TCP, as the case may be, before tender opening date. Furthermore, the Security Company against whom black listing process has been initiated or they have been black listed by TCP is not eligible to participate.
- 1.5 A pre-bid meeting of the Tender shall be held on 30th April 2024 at 1100 (hours), in the TCP's Board Room, interested bidders are encouraged to participate.
- 1.6 The partial offer of services by a bidder as not covering all of the specified sites at Clause-3.3 (at the cities of Karachi, Multan and Islamabad) shall result in rejection of the same bid.

2. **DEFINITIONS**:

- 2.1. Supervisor means a person physically & mentally fit preferably retired Junior Commissioned Officer (JCOs) of Armed Forces or Officer of any Armed Force to be employed as Supervisor upto the age of 50 years in proper uniform who should be on the payroll of Security Company and trained to provide the Security Services and equipped with essentially required logistics supports for effective monitoring and communication. He should be conversant with office work, possessing leadership skills and administrative control over the Security Guards posted by the Security Company against this agreement. He shall have Matriculation and 5 years experience as a security guard and working knowledge of Front Role Public Handling and Security Management Skills.
- 2.2. **Ex-Army Guard** means, a person physically & mentally fit having experience of serving in field intelligence or Military Police or Armed Force.
- 2.3. Armed Guard means a person physically & mentally fit in proper uniform who should be on the payroll of Security Company and trained to provide the Security Services and equipped with useful arm & ammunition like Pistol of 9 mm and Shotgun, along with valid license and other essentially required logistics supports for effective monitoring & communication which could be required to provide the sufficient Security Services on the place of posting and vicinity. He shall have working knowledge of Front Role Public Handling and Security Management Skills.



- Q.4. Guard and / or Unarmed Guards means, a person physically & mentally fit in proper uniform who should be on the payroll of Security Company and trained to provide the Security Services and equipped with essentially required logistics supports for effective monitoring & communication, which shall be required to provide the sufficient Security Services on the place of posting and vicinity. He should have working knowledge of Front Role Public Handling and Security Management Skills.
- 2.5. Place of Posting The area, where the specific Guard has been posted to provide the Security Services, in writing by the appropriate authority.
- 2.6. Shift the uninterrupted duration of twelve hours beginning from 0700 hours to 1900 hours and 1900 hours to 0700 hours for day and night shifts, respectively.
- 2.7. Mobile Vehicle Four wheel automobile, pickup, with engine capacity of not less than 1000 CC to consume petrol or diesel fuel only. It shall be in road worthy and in suitable condition and fit to use for patrol, emergency response and transport of security personnel for effective discharge security services (Fitness/road worthy certificate of Traffic Police be provided).
- 2.8. Wireless Sets Pair of more than two devices, to be used for two way oral communications, directly, without intervention and requirement of communication mean with approved frequency. (Cellular Services and CDMA Services cannot be used as wireless sets under this agreement), as per requirement of area and with the approval of site Incharge/Managements (rates must be included in the quotation).
- 2.9. **Walky-talky** Pair of two devices, to be used for two ways oral communication, directly, without intervention and requirement of communication mean with approved frequency. (Cellular Services and CDMA Services cannot be used as wireless sets under this agreement) as per requirement of area and with the approval of site Incharge/Managements (rate must be included in the quotation).
- 2.7. R.O. means Regional Office of TCP located at Islamabad and Gwadar.
- 2.8. S.R.O. means Sub-Regional Office of TCP located at Multan.
- 2.9. Any other terms used in this tender shall be treated as its original and understandable meaning in respect of provision of Security Services smoothly.
- 2.10. Lethargic, inefficient, over and below age guards will not be accepted.
- 2.11. The Security Guards so posted by the security agency under this tender must be APSAA (All Pakistan Security Agencies Association) certified in weapon handling. APSAA certificate for each individual guard shall be provided by the security company to the General Manager / Incharge REOD, TCP.
- 2.12. The Security Company must be registered with the Social Security Department of Provincial Government and EOBI as per Employees' Old-Age Benefits Act, 1976, which extends to the whole of Pakistan and applies to every industry or establishment, wherein ten or more persons are employed by the employer. The Security Company shall provide the services of only EOBI registered Security Personnel.
- 2.13. After deployment of security guards, company shall provide the vetting / clearance of those guards from special branch within 30 days to General Manager / Incharge (REOD).

3. PLACEMENT OF GUARDS AND ALLIED SERVICES:

- 3.1. Security Guards shall be provided without gap for twenty four hours (24) per day and seven (7) days per week at the TCP's premises. For this purpose duty rosters of the supervisors/guards must be provided to the TCP site In-charge.
- 3.2. The Security Company is responsible to provide security, manpower, Ex-Army Guards, Armed Guards, Un-Armed Guards and Supervisor as per following minimum requirement/ standards:-
 - 3.2.1. <u>SECURITY SUPERVISOR PREFERABLY RETIRED JUNIOR COMMISSIONED OFFICER</u> (JCOs) OF ARMED FORCE TO BE EMPLOYED AS SUPERVISOR:-

T-Shirts, Trouser, Jockey Cap, or Barret, Belt, Shoes.

3.3 Schedule for posting of Security Guards shall be prepared by General Manager / Incharge (REOD) in consultation with <u>Incharges of Godowns</u>. However, following schedule of deployment shall remain unchanged for the purpose of this clause.

- 3.5 Security Company shall provide the details of Guards alongwith their past experience, copy of CNIC, copy of Service Card and other required details/information to Godown/Site Incharges and General Manager/Incharge (REOD), one week prior to placement of Guard to the place of posting.
- 3.6 Security Company will ensure that the Security Guard is active, healthy and free from any diseases. Allowed age limit for placement of Security Guard having 25 to 40 years duly trained will be preferred.
- 3.7 Security Company shall place <u>50% Security Guards</u>, at Godowns having the past experience of Ex-Armed Forces. This distribution shall be made in all the places of posting, or as per instructions issued by the General Manager / Incharge (REOD), TCP. The ratio may be separately maintained for Pipri, Landhi, Korangi Godowns.
- 3.8 Security Company will ensure that the Security Guard is well trained. The guard must have at least one year experience of any Security Company. Every Armed guard shall be equipped with



- proper functioning and at least Twenty-five bullets/cartridges shall be available with each armed guard.
- 3.9 Guards shall be on the pay roll of Security Company, preferably on the permanent slot, otherwise, in case of contractual employment, minimum period should not be less than six months.
- 3.10 During the hiring of Security Guards for TCP's sites, the offer/appointment letter may be issued and same would be sent to General Manager / Incharge (REOD) for record.
- 3.11 Any change in placement of Security Guards shall be made with prior information and approval of the General Manager / Incharge (REOD).
- 3.12 Security Company shall ensure the availability of adequate reserve guards at least (20%) of TCP's required strength.
- 3.13 Security Company shall ensure placement of Guards, strictly in accordance with agreement, Terms and Conditions.
- 3.14 TCP at its discretion can reduce/increase the number of guards, on agreed rate of payment and on the same terms & conditions. The Security Agency is responsible to provide the required Armed Guards or Un-armed Guards as soon as possible but within twelve hours. However, the Site Incharges, have to immediately inform the General Manager / Incharge (REOD). The verbal intimation would be duly followed by written request mentioning therein the circumstances / reasons on next day.
- 3.15 In case the Godowns/Site Incharges require the Security Guards or any facility by the Security Agency at the site beyond the approved strength, the written request would be sent to Real Estate Operations Division, TCP. The REO Division shall take necessary action for deployment of the required Security Guards. Security Agency shall follow all the instructions of General Manager / Incharge (REOD).
- 3.16 The Security Company will be responsible to provide the following additional facilities to the Security Guards at its own cost at following places: -
 - 3.16.1 One four (4) wheel vehicle of minimum engine capacity of 1000cc in good and road worthy condition along with petrol ceiling at QRG (Pipri)/Ghaghar Phatak for patrolling and other security purposes.
 - 3.16.2 Two (2) Motorcycle alongwith petrol ceiling at QRG (Pipri).
 - 3.16.3 Two (2) Bicycles for (Pipri), two for Korangi one for Landhi godown.
 - 3.16.4 10 Spot Lights at TCP's godowns in QRG (Pipri), 5 at Landhi and 5 at Korangi.
 - 3.16.5 Provide four or more Metal Detectors alongwith four (4) Searching Mirrors (latest model), at the following locations, all Exit/Entry points should be manned by Security Guards alongwith Metal detector and Mirrors:
 - a. PIPRI: Eight (8) Metal Detectors alongwith Eight (8) Searching Mirrors.
 - b. LANDHI: Four (4) Metal alongwith Four (4) Searching Mirror.
 - c. KORANGI: Four (4) Metal alongwith Four (4) Searching Mirror.
- 3.17 Every Guard should have a whistle along with torch.
- 3.18 Security Supervisor should have the Cellular Phone facility to make/receive calls / messages at any time.
- 3.19 All Godowns shall invariably be provided functioning Wacky Talkies (with extra batteries), torch and whistle.

4. SECURITY MEASURES:

4.1 The Security Company shall maintain the proper record at main gate during the IN & OUT of vehicle/visitors at site including CNIC No., Name, Vehicle No. and destination of each



person/vehicle entering in the Godown premises. The register shall be signed and stamped by supervisor and daily entry and exit of vehicles/person shall be shared with General Manager / Incharge (REOD)/Incharge Godown on daily basis.

- 4.2 The Security Company shall be responsible to ensure the safety and security of TCP's assets both moveable and immovable including Cargo stored in warehouse.
- 4.3 The Security Company shall ensure proper handing over / taking over of the Inventory of all the Moveable and Immoveable assets of TCP's godowns. The Inventory Report must be signed jointly by the Incharge (Godowns) and the Security Supervisor of the Security Company to be submitted to the G.M. / Incharge (REOD).
- 4.4 Arms shall be in working condition at all the time. Armed Guards must be equipped with sufficient cartridges. Monthly drill may be performed at all Godowns.
- 4.5 Security Agency shall keep watch on all the activities of persons including TCP's officers/officials posted at Godowns and in case of any unauthorized transaction &/or incident of theft, removal of goods and damage to the property, the Security Company shall promptly inform in writing to G.M. (REOD) with copies to Director and S.O. to Chairman, TCP, in respect thereto and shall also lodge FIR with the concerned Police Station. The Security Company shall also be liable to indemnify/compensate TCP of all its losses so caused / suffered in this regard.

5. **GENERAL CONDITIONS:**

- 5.1. All the supervisors and guards would be required to mark their biometric attendance through retina/face/thumb impression recognition device to be provided by the Security Company at major locations i.e. Pipri, Landhi & Korangi Godown or where biometric device is available. This may also be reconciled from time to time with the attendance register maintained by TCP's Site Incharge. However, TCP official will facilitate and monitor the same.
- 5.2. TCP at its discretion can reduce/increase the number of guards, on agreed rate of payment and on the same terms & conditions. For this purpose, the Security Agency shall follow the instructions of General Manager / Incharge (REOD).
- 5.3. Security Company shall ensure the availability of adequate reserve guards at least 20% of the TCPs required strength. In case of absence casual or other leave by any Security Guard, the Security Company shall provide the alternate guard from the reserve guards.
- 5.4. Security Company shall ensure the placement of Guards, strictly in accordance with agreement, Terms and Conditions. Security Company shall also ensure the availability of trained fire fighting security guards as and when required by TCP's for deployment at TCP's storage godown including any private godown hired by TCP.
- 5.5. In case of absence of any Security Guard and Supervisor, the Security Company shall be liable to provide the required strength at site otherwise TCP reserve the right to impose the penalty as per agreement.
- 5.6. TCP can increase/decrease the number of guards. In this situation the Security Company will be informed in writing accordingly in case of number of guards increased/decreased upon directives of TCP.
- 5.7. The Security Agency will provide armed guards physically fit and sound in health, properly uniform and ensure that each guard must have following documents:
 - i. Attested photocopy of NADRA Computerized CNIC Card.
 - ii. Original Service Card issued by the Security Company.
 - iii. Photocopy of license/ certificate of weapon held by the guard.
 - iv. Copy of Certified discharge work issued by Ex-Armed Forces.

Without uniform, Lethargic, inefficient, over and below age guards will not be accepted.



- ,5.8. The Security Company would be responsible to cover all financial rates of Security Guards, including payment of salary and compensation to the Guards and all type of taxes and levies whether acquired through collective bargaining or otherwise and all the expenditure for providing allied services/medical/welfare. In case of illness during duties, Security Company will be responsible.
- 5.9. Any increase or decrease in any levies or rates imposed by the Government/CBA, wages and/or salaries fluctuation in market rates of equipment, materials, etc. during the currency of this agreement shall be on the Security Company's account and no claims for such increase shall be entertained by the TCP. Taxes will be withheld from payment as per rates providing on the date of payment.
- 5.10. Any taxes/duties already in place or levied by the Government during the currency of the agreement will be on Security Company's account and no claim shall be entertained by the TCP. If during the currency of this agreement or any renewal thereof any cess, tax charges or surcharge is levied in respect of the services which are subject of this agreement, by the Federal, Provincial or Local Government. Such cess, tax charges or surcharge, as the case may be, payable by the Security Company. Taxes will be withheld from payment as per rates applicable on the dates of payments.
- 5.11. TCP will not be liable to make any extra payment if the Security Company is to provide services in the event of any civil commotion, war, enemy action, hostilities, act of God or any other circumstance etc.
- 5.12. The Security Company will keep the TCP free from any liability for the cause of compensation to any employee of the Security Company in case of their injury, death etc.
- 5.13. Any claims of injuries, loss of limb or life of labour and other workers (Guards) engaged/employed by the Security Company for operations under this agreement or work connected directly or indirectly with the agreement shall be settled and paid by the Security Company. TCP shall in no way be responsible for any compensation in this connection.
- 5.14. Two month prior notice in writing shall be served by either party for termination of contract.
- 5.15. Upon the termination of this agreement, the Security Company shall be permitted to remove all its apparatus and equipment which may have been placed in the premises under intimation to General Manager / Incharge (REOD) installation and maintenance will be the responsibility of Security Company.
- 5.16. TCP shall make the payment to the Security Company on monthly basis after receipt of bill in detail alongwith biometric attendance sheet and list containing instruction of Security Supervisor and Un-Armed Guards/Armed Guards duly verified by site Incharge through REOD Division, Head Office.
- 5.17. The payment of Security Company shall be released within the 30 working days after the completion of all codal formalities as per Clause-15 on sufficient provision of all relevant documents by the company.
- 5.18. The guards at the gate of warehouse shall maintain inward and outward register & gate passes showing details of arrival/dispatches of cargo from TCP's warehouses and person visiting warehouses.
- 5.19. The Security Company shall be responsible to complete all documentation, if notified from time to time.
- 5.20. The Security Company shall be responsible to maintain all the record and documents relating to the award and performance of contract, alongwith details of Guards for onward submission to General Manager / Incharge (REOD) or any other lawful purpose as and when required.
- 5.21. The Security Company shall possess minimum experience to provide Security Services including placement of Guards with at least three Government Departments or Multinational or Listed Companies with minimum placement of 300 Ex-Army Guards, Armed Guards and Un-Armed Guards round the clock.



- 5.22. Affidavit on non judicial stamp paper of Rs.100/- to the effect that there was no previous litigation of the contractor or his employees/guards with TCP & other Government/Public Sector Organization and another Affidavit to the effect that the contractor has not been blacklisted by any Government Department/Autonomous Body/Corporation etc.
- 5.23. The Security Company will ensure that they have enough financial capacity to pay at least two month salary timely to the deputed Security Guards/Manpower in TCP and Security Company should submit such undertaking signed by CEO/CFO or Managing Partner on attested non judicial stamp paper of value Rs. 100/- as per (Annex-V).
- 5.24. The Security shall ensure disbursement of salaries/wages to the Security personal on or before 5th of each calendar month against the service rendered by Security Personal in preceding month.
- 5.25. The minimum salary / wages of the security personal shall not be less than minimum wages as notified by the Federal / Provincial Government and its evidence in shape of payroll and bank statement shall be provided to TCP on monthly basis. In case of any litigation in this regard, the Security Agency shall be responsible and TCP shall, in no way, be responsible for any liability in this regard.
- 5.26. New any Taxes/duties already in place or levied by the Government during the currency of the contact under this tender will be on account of Successful Bidder/Contractor and no claim shall be entertained by the TCP.
- 5.27. Bids for requirement of security guards as per (Annex-I) and security guards having training of fire fighting as per (Annex-II) will be treated separately.

6. VALIDITY OF OFFER/BID:

Offer/Bid should be valid for sixty (60) days w.e.f. date of opening of Financial Bids.

7. FINANCIAL PROPOSAL:

- 7.1 The (Financial Proposals) Bid Form shall be submitted separately on the prescribed format (Annex-I and Annex-II).
- 7.2 Taxes shall be applicable as per law.
- 7.2 Conditional and alternate bids will be rejected.

8. BID SECURITY/ PERFORMANCE GUARANTEE:

- 8.1 Bid shall be accompanied as per Annex-I and Annex-II in original by a Bid Security in the form of a Demand Draft/Pay Order for an amount of Rs. 1,000,000 (one million only) in favour of Trading Corporation of Pakistan.
- 8.2 Bid Security of the successful Bidder (s) will be retained, until submission of the performance guarantee as per Clause-8.4 below and Bid Security of un-successful Bidder(s) will be returned within seven (07) days of the award of the contract to the successful Bidder(s).
- 8.3 Bid Security of the successful bidder may be forfeited without any notice if the successful bidder fails to sign the contract, integrity pact & provide performance guarantee within due date.
- The successful bidder(s), before signing of the contract, shall submit Performance Guarantee in shape of a Demand Draft/Pay order in favour of Trading Corporation of Pakistan (Pvt.) Limited, issued by a scheduled bank equivalent to five percent (5%) of the total contractual value (as to be calculated on the basis of offered rate per month multiplied by 12 months) within five working days from the date of award of contract, for due and satisfactory performance of the contract which will be returned after satisfactory completion of the contract in accordance with Tender terms and conditions and settlement of any/all claims to the satisfaction of TCP.

^c 8.5 Performance Guarantee of the successful bidder shall be forfeited, if Security Company fails to provide the services as per tender terms & conditions / agreement.

9. BASIS OF OFFERS/ PRICE:

- 9.1 Bidders are required to submit the separate rates for supervisor, armed guard and un-armed guard as indicated in relevant column of the Bid Forms annexures mentioned at clause-7.1.
- 9.2 For placement of Security Personnel, the rates should be quoted in Pak Rupees, category-wise per personnel as per Bid Form (Annexure-I and Annex-II).

10. CRITERIA FOR TECHNICAL EVALUATION BASED ON MARK/SCORE:

Bids (Technical Proposal) shall be accompanied with the following document, otherwise the bid alongwith incomplete documents shall not be considered for Technical Evaluation.

- 10.9 TCP reserve rights to demand/call any other information for the sake of documents/information.
- 10.10 Holding Communication wireless license for the equipments/gadgets from relevant authority.
- 10.11 Three years experience proven track record in the market as a security service provider (Attach Photo Copies of Evidence).
- 10.12 Experience with Semi Government, Multinational and Foreign Missions (Attach Photo Copies of Evidence), if applicable.
- 10.13 Details along with office addresses in Karachi, Lahore, Islamabad, Multan etc.
- 10.14 Company Profile.
- 10.15 In case of Private Limited firm/company then Memorandum of Article of Association be provided.
- 10.16 Copy of Professional Tax Certificate (Issued by Excise & Taxation Office of relevant province).
- 10.17 Original Certificate of Bank showing that the firm/company maintaining the account in said bank.
- 10.18 The Bidder obtaining Seventy (70) Marks in the Technical Evaluation (Annex-III) shall qualify for competition in the next stage, i.e. Financial Proposal's evaluation and their Financial Bids will be opened in presence of their representatives.
- 10.19 Any Condition/Alternative shall invite the rejection of bids/offer.
- 10.20 Proof as Active Tax payer status with Federal and provincial Tax Authorities.



11. ELIGIBILITY:

- 11.1 The Security Company Should be:-
 - 11.1. A 'Limited', in accordance with 'The Companies Act 2017'.
 - 11.1. B Holding the valid Licenses of Security Company from Province of Home Departments and/or Ministry of Interior of concerned registered associations.
- 11.2 Holding the valid NTN Certificate.
- 11.3 Holding the valid GST registration.

12. INELIGIBILITY:

- 12.1 If the Security Company declared as Blacklisted by any Government body.
- 12.2 If the Security Company declared as defaulter by any Government body Public Sector Organization.
- 12.3 If the Security Company is involving in litigation with any Government/Public Sector Organization.
- 12.4 If the contract with Security Company terminated due to non-satisfactory performance.
- 12.5 If TCP having any kind of claim against the Security Company.
- 12.6 The Interested parties who have not fulfilled their contractual obligation with TCP shall not be eligible to participate in the Bids, unless they clear their dues along with penalties or fulfill their contractual obligations in services with TCP, as the case may be, before tender opening date. Furthermore, the Security Company against whom black listing process has been initiated or they have been black listed by TCP is not eligible to participle. Detailed requirements are indicated in the Tender Document containing tender terms & conditions.
- 12.7 TCP reserves the right to accept or reject the bids before their acceptance as per PPRA Rules.

13. DOCUMENTS CONSTITUTING CONTRACT:

- 13.1 The Security Company shall sign the contract agreement on Judicial Stamp Paper of appropriate value with TCP, within one week from acceptance of the offer by TCP. The Tender Documents signed and stamp by the bidder shall be integral part of the same contract agreement.
- 13.2 The IFB (Invitation for Bids), the Terms & Conditions of Tender and the Letter of Acceptance shall also be treated as an integral part of the contract.
- 13.3 Security Company shall sign the "Integrity Pact" immediately on award of contract as per format enclosed (Annexure-IV).

14 PENALTY:

14.1 In case of Non provision of additional facilities as prescribed at clause (3.15), TCP reserves right to deduct upto 30% of the total monthly bill payable to the security agency. However, deductions shall be made as per following criteria:

- 14.2 In case of non-placement of required number of security personnel, TCP has right to deduct the amount of **Rs. 1000/-** as penalty on account of each security personnel guard of such shift (each shift) in addition to deduction of daily wages of the respective absentee guards of such shifts from the monthly bill on account of payable wages as may be submitted by the Security Company.
- 14.3 If the security company fails for disbursement of salaries/wages to the Security personal on or before 5th of each calendar month against the service rented by Security Personal in preceding month, minimum 5% plenty of the bill can be imposed and the same can be deducted from the bill of security company.
- 14.4 In case of any damage/loss to TCP due to Security lapse, for determination of liability a committee constituted by the management of TCP has to give initial findings to be considered by the management take appropriate measures. The decision of the management in this regard would be binding on the Security Company.
- 14.5 Besides penalty, TCP can take any appropriate action, which may include the Suspension/Blacklisting of the contractor in accordance with the rules/law on account of Security lapse of employee of Security Company or otherwise.
- 14.6 In case of any theft/damage at Godown premises, the security company will be held responsible to pay the entire losses to the Corporation as determined by the Committee constituted by the Competent Authority.
- 14.7 In case of absence of any security personnel from his place of duty more than three shifts in a month, TCP reserve rights to deduct the whole or partial salary for such personnel/shift in addition to other penalty as deemed appropriate.
- 14.8 In case of placement of Un-armed guard or inefficient guard/placement of over-aged guards, lethargic guards & guards without proper uniform, TCP reserve the rights to deduct the whole or partial salary for such guards in addition to other penalty as deemed appropriate.

15. PAYMENT:

- 15.1 100% payment of the bill will be made after completion of each month. Taxes will be deducted as per law at the rates applicable on the date of payment.
- 15.2 The Security Company shall be required to submit the following documents alongwith bill:-
 - 15.2.1 Invoice with covering letter, both duly signed and stamped by authorized officer, separate for each location.
 - 15.2.2 Original bio-metric monthly attendance sheet of the security Guards duly verified by the site Incharge.
 - 15.2.3 Police verification of each guard, who performed the duties during the billing month, must also be provided with the bill. The wages/charges of un-verified guards shall not be processed till provision of police verification.
 - 15.2.4 Copy of any/all correspondence made with TCP or any other agency/person/ organization during that month.
 - 15.2.5 Any other details/documents, if required by TCP.
 - 15.2.6 Evidence / support of all claims in bills.
 - 15.2.7 Copy of CNIC of every deputed guard duly attested alongwith his Cell Number.



15.3 Payment shall be made through crossed cheque or online transfer, within 30 days after receipt of the monthly bill from the Security Company. Security Company is required to provide all the relevant and complete documents properly for early processing of the bill by 5th of the next month. If the bill is submitted later than 5 days, the payment due on said month may also be accordingly delayed. TCP requires at least 30 days for processing of payment.

16. PERIOD OF CONTRACT AGREEMENT:

17. CANCELLATION OF CONTRACT:

- 17.1 The Contract may be terminated earlier at any time by the TCP for breach of any provision(s) of the agreement by the Security Company. The decision of the Management shall be final and binding on the Security Company.
- 17.2 This agreement may be terminated by either party by giving to the other side two month's prior notice in writing.
- 17.3 Upon issuance of three Warning as non-compliance of agreement/terms and conditions of the tender documents, the contract with security company will stand terminated.
- 17.4 Upon the termination of this agreement the Security Company shall be permitted to remove all its apparatus and equipment which may have been placed by it at the premises, subject to obtaining permission from TCP.
- 17.5 In case of any serious violation made by the Security Company, TCP can terminate the agreement without any notice.

18. <u>DISPUTE SETTLEMENT:</u>

Any difference or dispute or liability of whatsoever nature arising out of the contract or in any way relating to the contract or to its construction or fulfillment, should be settled as far as possible, amicably between the TCP and The Security Company. Should the parties fail to come to an amicable settlement the same shall be referred to the Chairman TCP, for final decision. The decision of Chairman TCP shall be final and binding on both the parties.
