5. Technical evaluation Committee of Motorway M-4, evaluated the firms' documents & samples provided, in the light of prevailing government instructions (as mentioned in Standard Bidding Documents):

6. (03) Three above mentioned firms participated in the Tender for purchase of Miscellaneous store items. **M/S Malik Enterprises, Toba Tek Singh, M/S New Asif Traders, Toba Tek Singh & M/S Mian Abdul Shakoor Traders, Toba Tek Singh** have quoted/applied for all items in the Tender for purchase of Miscellaneous store items for M-4 Sector-I and Sub-Sector M-4.


7. The technical committee statements /observations are as follows:

- **M/S Malik Enterprises, Toba Tek Singh** technically **Qualified** by the Technical /Purchase Committee for **(57) items** after evaluation /checking of samples provided by the firm. However, the firm failed to

submit samples for two items (i.e. Table Cloth & Table Sheet) hence, disqualified for these (02) items.

- **M/S New Asif Traders, Toba Tek Singh** technically **Qualified** by the Technical /Purchase Committee for **(57) items** after evaluation /checking of samples provided by the firm. However, the firm failed to submit samples for two items (i.e. Table Cloth & Table Sheet) hence, disqualified for these (02) items..
- **M/S Mian Abdul Shakoor Traders, Toba Tek Singh** Technically **Qualified** by the Technical /Purchase Committee for **(51) fifty one** Misc. Store items after evaluation /checking of samples provided by the firm, except (08) items (i.e. Basket/ Plastic Shell, Water Set for Office, Socket Shoe, Peeler (vegetable scraper) for which the firm did not provide samples and Apron, Tea Cup with Saucer, Towel Large and Prayer Mat, which were not as per specification / standards of NHMP). Hence, disqualified for these (08) items stated above.

8. Hence, the Sector Technical Committee unanimously recommends to open the financial bids of **M/s Malik Enterprises, Toba Tek Singh, M/s New Asif Traders, Toba Tek Singh** for **(57)** items and **M/s Mian Abdul Shakoor Traders, Toba Tek Singh** for **(51)** items in which they technically qualified (list attached as Annex "A") for procurement of Miscellaneous Store items for financial year 2023-24, to evaluate the most advantageous bidder as per procedure.
