installed on each turbine to clean/filter combustion and enclosure vent air. Uch Gas Field is
situated in desert area of Baluchistan, owing dusty environment and frequent wind storms in
the area, the dust adheres on filter elements resulting in rise of DP across filters which causes
turbine tripping. Air intake filter elements are, therefore, replaced frequently as part of
preventive/predictive maintenance based upon DP across filters
