Failure of these pumps will result not only in shutdown of SRU but can damage the Shell & Tubes of Waste Heat Reclaimer due to low water level. Overhauling of 01 No pump is being forecasted since no maintenance schedule is available. No spares of HP boiler Pumps were indented since their installation and commissioning at new SRU. Instant indent was raised keeping in view the criticality of these BFW pumps.
