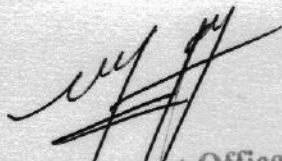

1. The documentary evidence i.e. copy of Bill of Lading must be provided with the consignment to prove that the material is imported from genuine source.			
2. Mill test/Principal's certificate regarding specifications chemical analysis of the material must be provided with the consignment.			
3. Delivery period is 60 days from the date of placing the order.			
4. Tenders must be accompanied by earnest money at the rate of 2% of the total value of the stores quoted. Earnest money must be submitted in the form of Pay Order/Call Deposit/Bank guarantee only from scheduled Bank in favour of Master of the Mint, Pakistan Mint, Lahore and valid for 120 days from the date of opening the tender.			
5. Single rate should be offered in a Tender. If the party desires to offer alternate rates, separate tender documents for each rate must be purchased; otherwise their offer will be rejected at the time of opening the tender.			
6. Rates quoted should be on free delivery to consignee store basis i.e. Pakistan Mint, Lahore.			
7. Rates quoted should be firm & final inclusive of all taxes and duties including General Sale Tax. Tenderer should note that if during the currency of contract, any tax or duty etc. is levied by the Government; it would be the liability of the tenderer.			
8. Rates quoted should be valid for at least 03 working days from the date of opening the financial bid, excluding the date of opening.			

9. Delivery must be completed within the period mentioned in the tender or Purchase Order.
10. The supply should conform to the relevant specifications failing which the same will be rejected and removed at the risk and cost of the supplier.
11. The weight of the stores will be carried out at the Mint Scale. However weighment on one or more weigh bridges outside Pakistan Mint Lahore may be carried out for the confirmation of the Mint weight however the lowest weight of each loader / Truck / Carrier will be considered.
12. The Payment will be made after receipt of bill along with sales tax invoice, copy of bill of lading, Mill Test Certificate, weighments report; chemical analysis report from Mint Assay Laboratory or any other Laboratory on the discretion of Master of the Mint and GRS/M.R. Note.
13. The tax exemption will be granted on presentation of the original or attested copy of paid bill of entry, subject to payment of Income Tax. The attestation should be from Custom Authorities not less than a BPS 17 Custom Officer. In case of original, an attested Copy of bill of entry will be returned on demand. In case of exemption regarding manufacturing process, it will be granted on provision of substantial evidence, e.g. original size of the Cathode imported, duly supported by exemption from FBR.
14. The successful tenderer shall provide Performance Bond @ 5% of the total value of the tender in the shape of CDR or unconditional and irrevocable Bank Guarantee issued by a Scheduled Bank within seven days from the date of letter of intent before placing the order. Thereafter, 2% earnest money will be refunded. The bidder is required to provide full Address, Phone No. & Fax number of the Bank issuing Performance Bond.
15. If the supplier withdraws tender and does not provide performance security the earnest money will be forfeited.
16. The supply of stores must be completed within the specified delivery period of 60 days. If the tenderer fails to supply the stores within the specified delivery period, the liquidated damages @ 2% per month for the late supply will be charged on prorata basis maximum up to 10% of total value. However, the extension in delivery period will not be for indefinite period, and will be the entire discretion of the Master of the Mint to grant extension or cancel the order with forfeiture of Performance Bond after the expiry of the delivery period as mentioned in the tender.
17. Tenderer should be registered suppliers who are on active taxpayer list (ATL) of FBR.
18. If the Tenderer is not on active taxpayer list (ATL) the payment will not be made till his appearance on ATL of FBR.
19. Photocopy of National Identity Card of the person signing the tender should be attached with the tender form.
20. Performance Bond must be furnished on the judicial stamp paper of value Rs.1000/- valid at least for 120 days.
21. Tenderer must provide a Certificate/declaration of fees, commissions and brokerage etc. on the letter head with his bid (specimen attached) which will be the part of contract.
22. Stores offered must conform to Mint specification.

23. **Procedures of open competitive bidding;** Save as otherwise provided in these rules the following procedures shall be permissible for open competitive bidding as per PPRA Rule 36 (a) namely;-

(24) Single Stage – two envelope procedure

- (i) The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal:
- (ii) The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion:
- (iii) Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened.
- (iv) The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened.
- (v) The procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirement:
- (vi) During the technical evaluation no amendment in the technical proposal shall be permitted:
- (vii) The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
- (viii) After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders;
- (ix) The bid found to be lowest evaluated bid shall be accepted.

25. The Mint Master reserves the right in the public interest:-

- a) To accept or reject the tender before acceptance.
- b) To amend or change the quantity of stores included in this tender while placing the order in public interest.
- c) To waive off or amend any of the conditions specified in the tender/purchase order.





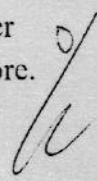
