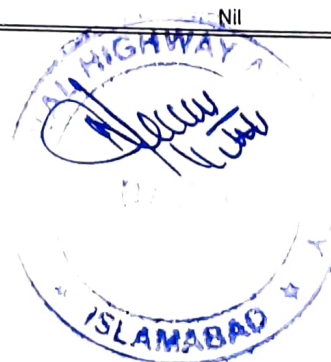

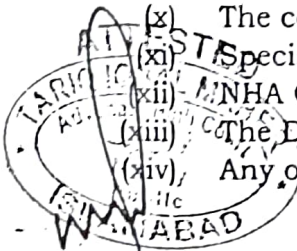
CONTRACT AGREEMENT

WHEREAS the Employer is desirous that certain Works, viz **Contract No.PM-NA-2020-21/N-35/02** for Periodic Maintenance Work (Structural Overlay) between Km 100+000 - 115+000 on KKH N-35 at the bid cost **Rs.307,689,451/-** (Rupees Three Hundred Seven Million Six Hundred Eighty Nine Thousand Four Hundred and Fifty One only) should be executed by the Contractor and has accepted a Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW this Agreement witnesseth as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.



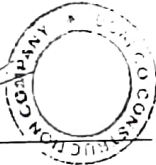

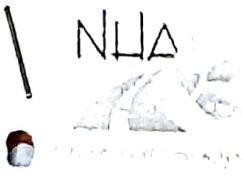
