- NEED ANALYSIS (Why the procurement was necessary?)  
The indented spares are used for repair & maintenance of ground electronics of 03 Nos 428XL Seismic Data Acquisition systems, 02 No. G3I data acquisition systems and 05 No. NZXP-II WZ data acquisition systems present in 05 seismic parties for smooth field operation. These spares are sub-parts of ground electronics (telemetry cables) of seismic data acquisition systems and being procured to repair ground electronics (telemetry cables) worth approximately USD 4.76 Million. The ground electronics including telemetry & spread cables are laid on ground during seismic data acquisition and shifted from one profile to another by labor/vehicles frequently, due to which they become damage. Moreover, harsh weather conditions & environment cause damage to these items. These damage cables having multiple joints consume precious acquisition operational time that would be saved by repairing these damage cables. Therefore, indented spares are essentially required.
