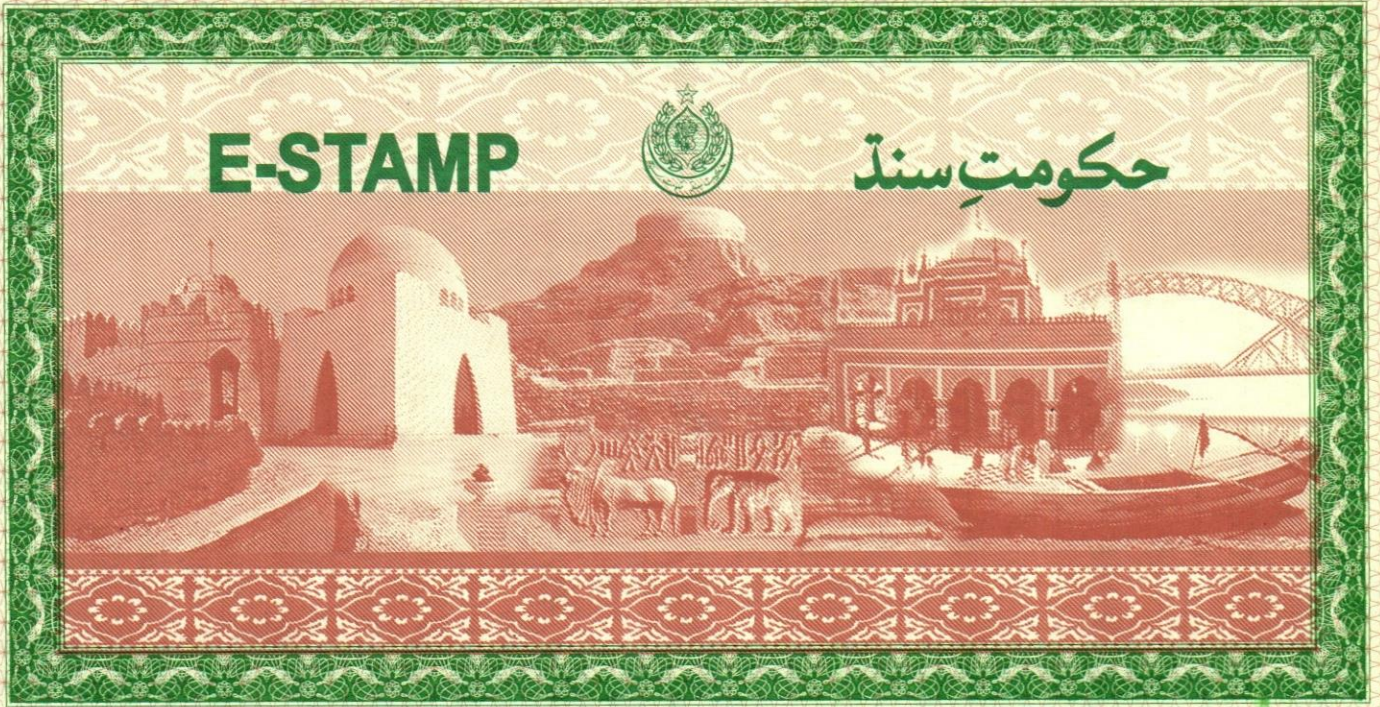

- BY & BETWEEN -

PAKISTAN NATIONAL SHIPPING CORPORATION is a statutory Corporation established under the Pakistan National Shipping Corporation Ordinance No. XX of 1979, having its Head Office at PNSC Building, Moulvi Tamizuddin Khan Road, Karachi Pakistan (hereinafter referred to as the "Corporation" which expression wherever the context so permits shall include the legal representatives and assigns), party of the **ONE PART**.

- AND -

M/S The Times Press (Pvt) Ltd. having their office C-18, Al Hilal Society, Off: University Road, Karachi (hereinafter referred to as the "Publishing House", which expression wherever the context so permits shall include the legal representatives and assigns) party of the **OTHER PART**.

WHEREAS PNSC is desirous that publishing of Annual Report 2022 should be conducted and should be provided by the publishing and has accepted a bid by the Publishing House for execution.

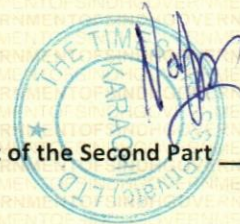
AND WHEREAS the Publishing House warrants that it has the requisite know-how, experience, resources and personnel to carry out the publishing of Annual Report 2022 and to provide the required services to the full satisfaction of Corporation, subject to the Terms and Conditions set out in this Contract.

- In this Contract words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- i. In consideration of the payments to be made by PNSC to the Publishing House as hereinafter mentioned, the Publishing House hereby covenants with PNSC to conduct publishing of annual report of PNSC in accordance with the provisions of the Contract.
- ii. PNSC hereby covenants to pay the Publishing House, in consideration of the execution and completion of the Contract such sums as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
- iii. The bidder shall submit 5% of Contract amount as **Performance Guarantee**. This will be refunded after completion of Contract / satisfactory report.
- iv. The successful bidder shall affix the contract form and terms & conditions on non-judicial paper of Rs. 100/- and stamp for stamp duty (@0.35 Thirty Five Paisa) for every Hundred Rupees of Total Contract Amount.

TERMS & CONDITIONS TO BIDDERS

1. SECURITY DEPOSIT / PERFORMANCE GUARANTEE

In case of successful bid, the bidder shall submit 5% of Contract amount as Performance Guarantee. This will be refunded after completion of Contract / satisfactory report.

2. DELIVERY

i. On receipt of each work order, the contractor shall immediately collect printing material from the corporation's finance department / shares department, and shall arrange printing and delivery of accounts strictly within the period specified in each work order. It is hereby declared that, unless agreed otherwise between the corporation and the contractor in writing, the printing time shall not exceed the following limits:

Annual Accounts	Ten days from the date of the Approval of Final Proofs/Dummy of Annual Report.
Half-yearly / Quarterly Accounts	Four days from the date of the Approval of Final Proofs.

ii. All printed accounts and envelopes shall be delivered by the contractor to the shares department of the corporation at PNSC Head Office or at by any other place as specified in the work order, which in no case shall be outside the limits of Karachi city. For the purposes of billing, the contractor shall, upon satisfactory delivery, obtain a job completion certificate from the said shares department.

iii. All transportation, handling and other allied charges of whatsoever nature shall be borne by the Contractor.

MELY COMPLETION

- i) The contractor hereby accepts that time shall be of the essence of this contract.
- ii) In the event of failure of the contractor to execute the work strictly according to the specification and within the time specified in each work order, the corporation shall have the right, without prejudice to any other right or remedy available under this contract or at law, to have the work executed by any other printer at the cost.

3. BILLS PAYMENT

- i) The contractor shall submit bills for payment within 15 days of completion of job to the Administration Department of the corporation as per agreed rates together with delivery challan, job completion certificate referred to in clause 2(ii) above and such other supporting documents as may be necessary to process payment. Subject to due scrutiny and verification of proper delivery, payment against each bill shall be released to the contractor within three weeks of receipt thereof.
- ii) The payment will be made on submission of bill within 30 days, mentioning actual quantity ordered and delivered duly supported by acknowledgement of PNSC's authorized officer on supplier's delivery challans within 20 days of complete delivery.
- iii) All payments to the contractor under this shall be liable to such withholding tax, sales tax, professional tax etc. as may be applicable under the law. The corporation shall provide to the contractor certificate / challans evidencing such deductions by the corporation.


4. BRIBE / COMMISSION / GIFTS ETC.

Any bribe, commission, gift or advantage given, promised or offered by the contractor or any of the contractor's agents or servants to any officer, staff, representative of the corporation in relation to this contract or any other contract with the corporation shall render this and all or any of the other contracts liable to cancellation without notice, beside recovery of an amount from the contractor to be decided by the chairman of the corporation as "liquidated damages". The decision of the chairman of the corporation in this respect shall be final, conclusive and binding on the contractor.

5. PERMITS / LICENCES

The contractor shall at all times be in possession of valid licenses / permits from the concerned authorities, to perform the job of printing under this contract, and shall on request provide copies thereof to the corporation.

6. AUTHORITY OF SIGNING DOCUMENTS

The person signing this contract on behalf of the contractor shall be deemed to warrant that he has lawful authority to bind the contractor, and the person so signing shall provide letter of authority empowering such person to sign this contract and to bind the contractor, and if it appears that the person so signing has no authority to do so, the corporation shall have the right, without prejudice to other legal remedies, to forthwith terminate this contract without notice and hold the signatory and the contractor liable for all costs and damages.

7. SUB LETTING

The contractor shall not sublet, transfer or assign this contract or any part thereof without prior written permission of the corporation. In the event of contravention of this condition, the corporation shall be at liberty to cancel this contract and have the work executed at the risk and cost of the contractor, without notice.

8. FORCE MAJEURE

The failure on the part of the parties to perform their obligation under the contract will not be considered a default if such failure is the result of natural calamities, disasters and circumstances beyond the control of the parties.

i. No Breach of Contract

The failure of a Party to fulfill any of its obligations under the contract shall not be considered to be a breach of, or default under, this Contract in so far as such inability arises from an event of Force Majeure, provided that the Party affected by such an event (a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event.

ii. Extension of Time

Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

iii. Payments

During the period of their inability to perform the Services as a result of an event of Force Majeure, the Consultant shall be entitled to continue to be paid under the terms of this Contract, as well as to be reimbursed for additional costs reasonably and necessarily incurred by them during such period for the purposes of the Services and in reactivating the Service after the end of such period.

9. TERMINATION FOR DEFAULT

PNSC, without prejudice to any other remedy for breach of Contract, by giving one month written notice of default sent to the Contractor, may terminate this Contract in whole or in part:

- a. If the Contractor fails to complete the contracted works / Services, within the period/s allowed specified in the Contract or within any extension thereof granted by PNSC;
- b. If the Contractor fails to perform any other obligation/s under the Contract and/or violation/contravention of any other terms and conditions mentioned therein;
- c. If the Contractor assigns any of this service and/or in case of found corrupt or fraudulent practices in competing for or in executing the Contract.
- d. If the PNSC during the completion period of the Contract has reason to believe that Contractor will not be able to fulfill obligations under the contract.

10. TENURE AND VALIDITY OF AGREEMENT

This contract shall remain valid for a period of one 01 year w.e.f 01-09-2022 and shall expire on 31.08.2023, unless terminated earlier in at mutual consent of both parties.

11. END / TERMINATION OF CONTRACT

This contract shall come to an end on 31-08-2023, unless terminated earlier in accordance with the provision of the contract

12. RECOVERIES AND PENALTIES

If the contractor fails to print / supply the accounts / report within the stipulated period the corporation may get the same printed at any other source and cover the extra expenses thus caused from the security deposit of the contractor. In case of delay in supply behind the stipulated period, any fines / penalties and levy's impose on PNSC for contravention or the violation of rules shall be recoverable from the contractor.

13. SETTLEMENT OF DISPUTES


- a. This Contract shall be governed by the laws of the Islamic Republic of Pakistan and the courts at Karachi shall have exclusive jurisdiction.
- b. Any claims, demands, cause of action, controversies, dispute (s) in relation to any matter connected with or arising out of the Contract including any question regarding its existence, breach, validity or termination and not amicably settled between the parties themselves shall be referred to arbitration by appointing a Sole arbitrator mutually accepted to the parties hereto. or to two arbitrators, one each to be appointed by the two parties, and the said Arbitrators shall appoint an Umpire before entering upon the reference, and the award of such Sole Arbitrator or the two arbitrators or the Umpire, as the case may be, shall be final and binding on both the parties. The arbitration shall be governed by the Arbitration Act 1940 as modified or re-enacted the venue of arbitration shall be at Karachi.






