MINUTES OF MEETINGS PERTAINING TO TECHNICAL AND FINANCIAL BIDS FOR PROCUREMENT OF FORENSIC HARDWARE, SOFTWARE TOOLS

To procure three units of branded laptops, two units of workstation towers and seven different Forensic Hardware/ Software Tools, bids were invited through a Tender Notice which was published in the newspapers as well as uploaded, along with detailed RFP, on the websites of CCP and PPRA. Last date for submission of the tenders and opening the technical bids was fixed on the 8th February, 2022.

2. Technical bids were opened on 08-02-2022 at 03:30 p.m. Three vendors submitted bids for supply of laptops, and the same number of bidders submitted bids for supply of workstation towers and four vendors submitted bids for supply of seven different hardware and software forensic tools. All the bids were technically found qualified. Financial bids were opened on the 22nd February, 2022. The Purchase Committee examined bids for procurement of above mentioned items. Detailed comparative statements have been prepared. The statement for supply of laptops may be seen at F/"A"; for workstation towers at F/"B" and for forensic tool at F/"C". Synopses of these comparative statements are as under:

3. It has been noticed that one bidder, M/s. Wise Tech has quoted rates for supply of 3 laptops (category-I) and 2 workstations (category-II) without GST but the other bidders with 17% GST. However, the comparative statements for these two categories have been prepared on the basis of rates without GST on the reason that previously the sale of computers was without GST but recently the Government has imposed GST on the computers @ 5%, therefore, while making payment to the successful bidder on supply of the items as mentioned in category-I and II with adding GST @ 5%.

4. The comparative statements for supply of 3 units of laptops (category-I) and 2 workstations (category-II) show that M/s. Wise Tech have quoted lowest rates as compared to other two bidders. For supply of 3 units of laptops (Lenova) they have quoted Rs. 736,398.00 and for 2 units of workstations (HP 280G6) the amount of Rs. 525,164.00 has been quoted.

5. For supply of seven hardware and software Forensic tools, four vendors submitted bids. Out of them M/s. Data Hawk quoted lowest price, i.e Rs. 8,083,805.00 as shown in statement for Categories-III- Forensic Tools.

6. Technical and Financial evaluation has been made in light of the criteria as laid down in the RFP. The marks/ points have been given to the bidders as per this criteria and the following situation has emerged:

7. The evaluation sheets as given in the previous paragraph show that for supplying 3 laptops (category-I) and for supplying 2 workstations (category-II), M/s. Wise Tech have obtained more points as compared to those of other bidders. For supply of forensic hardware, software tools (category-III) the marks obtained by M/s. Data Hawk are more than those of other bidders.

8. In view of above, the Purchase Committee recommends that three units of laptops (Lenovo Think book 151M) at the total price of Rs. 736,398.00 and two workstation towers (HP 280G6) at a sum of Rs. 525,164.00 may be purchased from M/s. Wise Teck, Islamabad and seven hardware and software Forensic Tools from M/s. Data Hawk at the cost of Rs. 8,083,805.00.





1. Description of Work

Competition Commission of Pakistan (CCP) invites separate sealed bids, on single stage two envelopes basis from authorized distributors/vendors having Sales Tax Registration and National Tax Number for supply of branded hardware and software with licenses as prescribed in Annexure-A. The bidders having their offices in Islamabad or Rawalpindi will be given priority.

2. Timelines

- Publication of Tender 17th January, 2022
- Bids submission deadline 8th, February 2022 up to 1500 hours
- Opening of Technical Proposals 8th February, 2022 at 1530 hours

3. Scope of Work

The proposed work is procurement, installation and configuration of the hardware and forensic software tools of the following two categories:

- I. Provision of Branded Laptop and Workstation Tower.
- II. Provision of Forensic Hardware and Software Tools.

Responding Organizations are allowed to bid for any of the above mentioned categories. They are requested to clearly mention the category or part of a category for which they are bidding on the main envelop of technical and financial proposals. Evaluation will be done separately for each category.

Competition Commission of Pakistan reserves right of awarding the tender for one or more items after opening of financial proposals.

Training: Responding Organisation (RO) shall be responsible for providing comprehensive training on all quoted items to the staff nominated by CCP.

6 General Terms & Conditions

6.1 Bid Bond

A bid bond, in the shape of a Bank Draft/Pay Order in the name of Competition Commission of Pakistan, equivalent to 2% of the total cost of bid should be submitted along with the tender. CCP reserves the right to forfeit the bid bond, if the information provided is not according to the various formats provided in this document.

6.2 Validity of the proposal

All proposal and price shall remain valid for a period of 90 days from the closing date of the submission of the proposal. However, the responding organization is encouraged to state a longer period of validity for the proposal.

6.3 Performance Bond (upon execution of Contract)

The successful vendor shall be required to deposit in the form of a Bank Guarantee, a Performance Bond upon execution of the contract, a sum equivalent to ten percent (10%) of the contract value. This Bank Guarantee shall be issued by a scheduled bank operating in Pakistan and the value for the outstanding deliverables of the contract will remain valid until the final and formal termination of Contract by CCP (this includes the warranty period). Competition Commission of Pakistan shall forfeit the Performance Bond if the responding organization breaches any of its obligations under the contract, including slippages in the committed schedules.

6.4 Undertaking

The bid should accompany an undertaking on the stamp paper of Rs. 50/- to the effect that the company provides 100% original products; that the company has not been black listed by any government, semi government or autonomous organization; that the company is not under litigation in any court of law or not at any stage of bankruptcy; and it has not supplied the same items to any department organization at the rates lower than offered in this tender during the same period.

6.5 Quality

While assessing the bids, quality of the items will be given proper weight. Lower rates for the lower, substandard or inferior quality will not be considered.

6.6 Maintenance and Support Service

Selected vendor(s) will provide maintenance/support service, after expiry of warranty, for each product at an agreed rate, if desired by CCP.

6.7 Penalty Clause

The contract to be executed between CCP and the selected vendor(s) will contain penalty clauses on account of failure to comply with the provision of providing the required services during the post-approval phase.

6.8 Currency

All currency in the proposal shall be quoted in Pakistan Rupees (PKR).

6.9 Withholding Tax, Sales Tax and other Taxes

The responding organization is hereby informed that the Government shall deduct all the tax at the rate prescribed under the tax laws of Pakistan, from all payments for supplies the goods and services rendered by any responding organization who signs a contract with the Competition Commission of Pakistan. The responding organization will be responsible for all taxes on transactions and/or income, which may be levied by government. The tender should be accompanied by the firm(s) Sales Tax Registration Certificate and National Tax Number.

6.10 OEM relationship and warranties

The responding organization should be authorized Partner/Reseller/ distributor, for the hardware and licensed software in Pakistan. Responding Organization having Tier one, Gold, Silver or premier partnerships with the original Manufacturer will be given preference in final evaluation.

All hardware equipment should have **one year comprehensive on site warranty including parts and labour**. Original CDs of all licensed software should be provided.

Selected vendor(s) will provide maintenance/support service, after expiry of warranty, for each product at an agreed rate, if desired by CCP.

The equipment supplied should be through verifiable distribution channel in Pakistan.

In case of forensic kits/ softwares authorization from Reseller/ Distributer of original software manufacturer will be given preference.

6.11 Ownership

The ownership of all products and services rendered under any contract arising as a result of this RFP, including any source code developed, will be the sole property of Competition Commission of Pakistan.

6.12 Contracting

The selected vendor(s) will submit Contract, as per draft to be provided by CCP, within seven days of issuance of LOI. In case of non-submission in the given date the LOI will be cancelled and issued to the runner up bidder.

6.13 Governing Law

This RFP and any contract executed pursuant to this RFP shall be governed by and construed in accordance with the laws of Pakistan. The Competition Commission of Pakistan and all responding organizations responding to this RFP and parties to any contract executed pursuant to this RFP shall submit to the exclusive jurisdiction to Courts at Islamabad.

6.14 Acceptance of Proposals

Financial Proposals of only technically qualified bidders will be opened. The decision of the Committee will be binding on all concerned and in no case will be challengeable at any forum. The CCP may reject all the bids or proposals at any time prior to acceptance of a bid or proposal under the provisions of Rule 33 (1) of the Public Procurement Rules, 2004.

6.15 Evaluation Criteria

- (1) The proposal which secures the highest marks (Technical+ financial) after meeting the following technical requirement will be considered most reasonable/ advantageous:
 - i. Low quality item/ brand will not be accepted.
 - ii. 70% weight will be given to technical evaluation and 30% to financial evaluation.
 - iii. The vendor/ bidder who fulfils all technical requirements, as given in this tender notice, will be given 100 marks which will be converted into 70 marks for final evaluation. Other bids will be awarded technical marks with the same ratio.
- (2) 100 technical mark will be calculated as under:
 - a). 50 points/ marks will be given to those bids wherein quoted items are in accordance with specifications given in this tender notice. No mark will be given to those proposals wherein quoted items are not in accordance with the given specifications;
 - b). 20 points for tax/ GST certificates;
 - c). 20 points for authorized dealership certificate;
 - d). 10 points for compliance with the bid format.
- (3) 30 points/ marks will be awarded to the lowest financial bid. The other bids will be evaluated with the formula: $\text{Lowest bid} \times 30 / \text{higher bid}$.
