

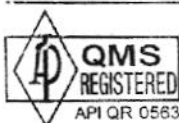

Technical Evaluation

Bids were sent to GM - I (D) - South vide memo ref. # SSGC/FP/9322 dated 31-Aug-2018. AGM (D) - C vide memo ref # AGM (D) - C/TE/3LPE/9322 dated 06-Sep-2018 formed a committee comprising of Mr. Altaf Soomro (DCE - Const - Central) & Mr. Javed Ahmed Junejo (Sr. Engr - Const - Central) for technical evaluation.

Technical Evaluation was submitted through AGM I (D) - C & GM - I (D) - South vide memo ref # TE/3 Layer PE Coating/9322/18 dated 11-Sep-2018 declared both bidders as technically compliant.

During the processing of commercial evaluation, it was observed that below cited clause was stated by M/s. Crescent Steel & Allied Products Ltd (CSAPL) in their bid, wherein confirmation/advice was sought from user in recent vide email dated 03-Oct-2018 (Flag-B) for acceptability & alignment with technical specification:

Quote:
We will accept bare pipes with standard mill coating which is hard to touch, even in thickness (<20 microns) and can easily be removed during shot blasting. If the mill coating is soft and the thickness is >20 microns, the removal will be charged extra over and above our quoted prices.

GM - I (D) South vide their email dated 04-Dec-2018 (Flag-C) clarified that lowest bidder i.e. M/s. CSAPL is technically compliant and further stated that there is no application of lacquer on locally manufactured bare pipe.

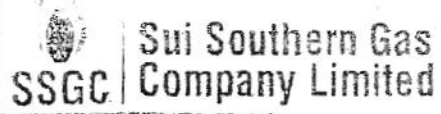
