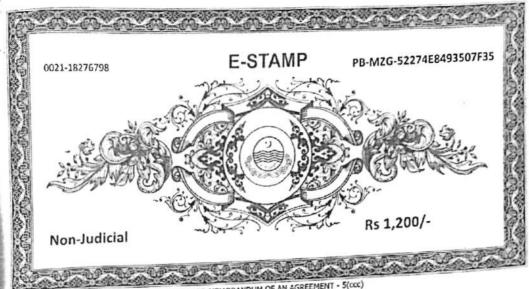

12. ### AGREEMENT

This agreement is made on this day of 11th August, 2022 at Lahore between M/S Pakistan Agricultural Storage & Services Corporation Limited, (PASSCO) incorporated under the laws of Pakistan with its registered office at 11- Kashmir Road Lahore represented by it's A/General Manager (Commercial) (hereinafter referred to as the "Buyer" which terms wherever the context so permits includes its successors in interest of the first party).

M/s Millennium Industries (Pvt) Limited, 4-Noon Avenue New Muslim Town Lahore. (hereinafter referred to as "Seller" which terms wherever the context so permits includes its successors in

interest of the second party).

WHEREAS, the seller has agreed to supply 4,850 (15%+/-) PP bales of 50 Kgs capacity bag containing 1,000 bags in each bale, at the rate of Rs.51.25 (Rupees Fifty One & Twenty Five Paisa only) per stencilled bag for the delivery as per clause 3 mentioned below inclusive of all taxes, duties, transportation, loading, unloading charges at the destination, to the buyer on delivered basis anywhere in Pakistan at the discretion of the buyer.

AND WHEREAS the buyer has agreed to buy the same at the above rate subject to the Terms &

Conditions containing hereunder to which stipulation the seller has consented.

NOW THEREFORE, THIS AGREEMENT WITNESSES:-

This agreement comes into force with immediate effect and shall remain operative till 15th

January 2023, including 15 days LD (Late delivery) period with charges.

During the above period, the supplier shall supply 4,850 (15%+/-) bales of Polypropylene Bags containing 1,000 bags of 50 Kgs capacity in each bale in accordance with the delivery schedule as given hereunder.

5. <u>SPECIFICATIONS</u> Besides those listed below the PP bags must be as per specifications approved given hereunder:-

### **Bags Specifications**

Tubular Woven P.P.Bags manufactured from prime virgin material with hemmed bottom and heat cut mouth ends on made of ultra violet stabilized polypropylene or with ultra violet stabilizer mixed with polypropylene for packing of wheat. In both the cases, the contents of UV stabilizer should not be less than 0.35%.

- Bottom seam The bottom of the bag should be folded once at sewn. The width of fold should be 2.54cm (1 inch)
- Stitching. Acid resistant thread of Nylon or polypropylene of 1000 denier should be used. Chain stitch should be used for sewing with at least 4 stitches per inch. The stitching should be uniformed without any loose thread.
- Drop Strength. The bag filled with 50 Kg wheat should be able to withstand without bursting at least 6 drops from a height of 16 feet when dropped flat.
- k. Printing. Printing design will be printed on one side of the bag in single Green colour.
- 1. Printing Ink. Non fading water proof ink should be used.
- m. Packing, 1000 PP Bags in one bale wrapped in new polypropylene woven fabrics
- n. Net Weight of each Bale: not less than 115 Kg
- o. UV Stabilizer: ≥ 0.35

### Price of Polypropylene Bags

- a. The seller shall charge Rs.51.25 (Rupees Fifty One & Twenty Five Paisa only) per stencilled bag on delivered basis anywhere in Pakistan inclusive of all duties, taxes, charges such as sales tax, export tax, octroi, loading, transportation, and unloading charges etc; at the destination.

- Respective Zonal Heads/OIC Liaison Office Karachi. will dispatch the Goods Receipt Advice (GRAs) and Visual inspection reports to all concerned wings including supplier within 7 working days after receipt of goods.
- 10. In case of rejection of PP bags by the Inspection Team, the supplier will be responsible to replace the defective/below specification PP bags within three days at the same destination (albeit within the contracted period), failing which party will be considered as a defaulter and action will be initiated accordingly by PASSCO.
- 11. The supplier may represent, against the decision to the Management of PASSCO within three days of the inspection and may also ask for joint inspection. Decision of Managing Director PASSCO on the report of joint inspection will be final and binding on both parties.

In case, part or whole consignment of PP bags is found defective/below standard/less in count as 2. In case, per specifications at destination, the recipient Zonal Head/OIC Liaison Office Karachi igainst tall down (Comm) and Inspection Team immediately through fax, email followed by post thall inform the days of its arrival). The objected consignment shall subject to joint inspection (by not later than three stapplier) at the destination. Subject to the recommendation of the joint inspection (by reps of PASSCO and supplier) at the defective quantity at party's cost within 7. reps of PASSCO and separation of the joint inspection team, supplier will replace the defective quantity at party's cost within 7 days of the issuance of team, supplier will PASSCO's discretion or otherwise, PASSCO may reduce the contracted quantity to replacement order at 17.55 the defected quantity of PP bags as ordered by PA 6000. the extent of defective quantity of PP bags as ordered by PASSCO, the supplier shall be the supplier fails to replace the defected quantity of PP bags as ordered by PASSCO, the supplier shall be considered as defaulted and be dealt with accordingly.

In case of late delivery, PASSCO will charge late delivery charges (LD) at rate of 2% of the cost of the delayed stock of PP bags for each 15 days or part thereof provided that are delivered within 15 days of the last date of each delivery schedule as laid down in the schedule for every consignment.

The supplier will strictly adhere to the delivery schedule as given in clause-3 above. In exceptional cases, extension in delivery schedule may be sanctioned by the Managing Director, PASSCO on specific and justified request of the seller; however the decision of MD will be final and binding.

In case, the supplier fails to deliver the agreed quantity or part thereof beyond 15 days of the final delivery date in respect of any consignment/schedule, PASSCO may rescind the agreement and forfeit security deposited, proportionate to the quantity defaulted. Additionally, PASSCO should purchase defaulted quantity of PP bags at risk and cost of seller, in that case extra expenses incurred by PASSCO shall be recoverable from the defaulted supplier either from the pending bills, payment, dues/securities or through legal recourse.

No claim on account of fluctuation in International, Local market rates, which may arise out of any cause, shall be entertained, provided, always that in the event of any duty of customs, excise or tax on the goods being imposed, increased, decreased or remitted, the seller shall not be entitled to add the
