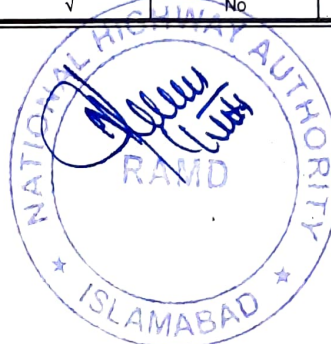

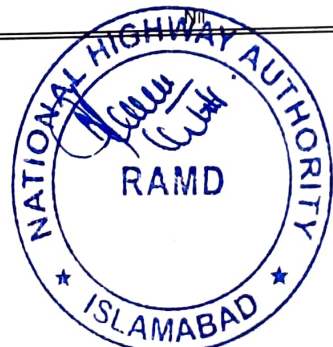

2. GENERAL

The Re-Invitation for Bids (Technical and Financial) through NHA's e-Bidding system was advertised on 2nd July, 2022 in various newspapers vide **PID(i) 9114/21** and also uploaded on NHA & PPRA Websites on 1st July, 2022 vide **TS484812E**. Copies of advertisements are available at **Annexure-A**. In accordance to PPRA rules Open Competitive Bidding based on "**Single Stage Two Envelope**" procedure is adopted for procurement of Periodic Maintenance Works in Northern Area's Region. The bids submission date was **21st July, 2022 at 1130 Hrs.** in the office of **General Manager (NA's)** House No. 394, Street No. 03 Jinnahabad, NHA, Abbottabad.



3. SUBMISSION OF BIDS

The time for submission of Bids was upto **1130 Hrs. on 21st July, 2022** for subject cited works as advertised and receipt of Bids were closed at 1130 hours local time on scheduled day. minimum category and 100% qualification of Lead Firm as per IFB/
Bidding documents is mandatory.

- b) Provision of No litigation/Non-Blacklisting certificate/Pending litigation Certificate on Judicial Stamp Paper.
- c) Provision of Staff list on Judicial Stamp Paper.
- d) Provision of Machinery list on Judicial Stamp Paper.
- e) Provision of other documents specifying the experience and financial capabilities of the firm.

WHEREAS the Employer is desirous that certain Works, viz Contract No.PM-2019-20/NA/01 for Periodic Maintenance Work (Structural Overlay) between Km 33+500 - 43+000, Km 53+000 - 56+000 & Km 60+000 - 70+300 on KKH (N-35) at the evaluated bid cost Rs.554,843,776/- (Rupees Five Hundred Fifty Four Million Eight Hundred Fourty Three Thousand Seven Hundred Seventy Six only) should be executed by the Contractor and has accepted a Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
