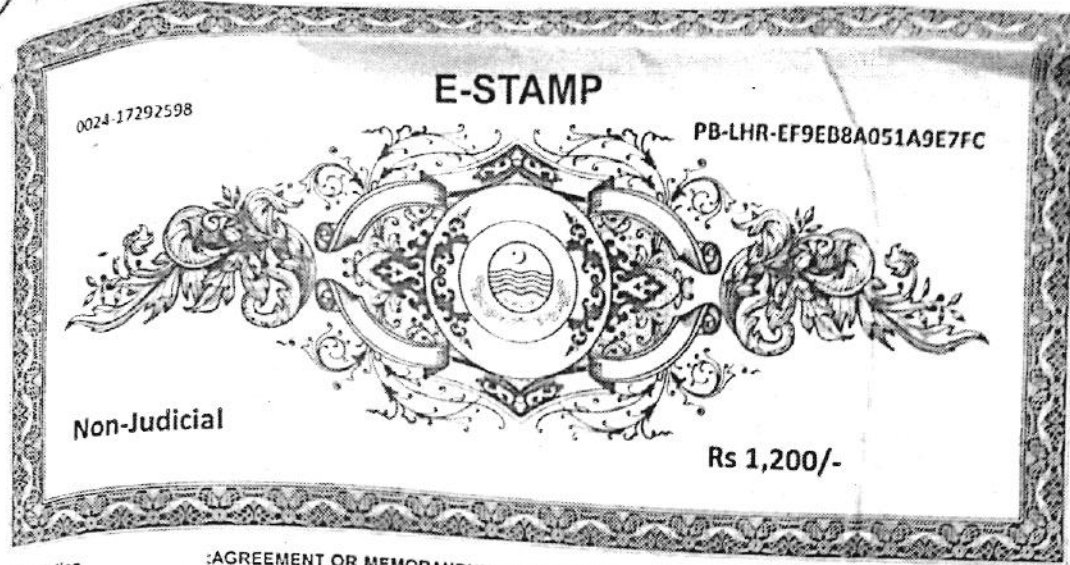

AGREEMENT

This agreement is made on 13.07.2022 at Lahore between M/S Pakistan Agricultural Storage & Services Corporation Limited, having its registered office at 11 – Kashmir Road, Lahore through General Manager Commercial (hereinafter referred to as first party “BUYER” which term wherever the context so permits includes its successors in office legal representatives, assigns etc.) of the first party (Buyer).

And

M/S AHY Plastic Industry (Pvt) Limited referred to as “SELLER” which term wherever the context so permits includes its successors in office, legal representative and assigns etc.) of the second party.

Whereas, the second party has offered to supply 123,000 Kgs Polyethylene Sheets @ Rs.575/- (Rupees Five Hundred Seventy Five Only) per Kg net weight on delivered basis at PASSCO destinations within Pakistan inclusive of all taxes / duties, and whereas the first party (Buyer) has agreed to buy the same at the above rate subject to the terms and conditions containing hereunder to which stipulation the supplier has consented.

NOW THEREFORE, THIS AGREEMENT WITNESSES:-

1. This agreement comes into force with immediate effect and shall remain operative till 30.12.2022 including 15 days late delivery (LD) period. **123,000 Kgs Polyethylene Sheets** will be supplied as per below mentioned schedule:-

1. Upto 20.07.2022 = 50,000 Kgs
2. Upto 15.12.2022 = 73,000 Kgs (as per requirement within given period)

3. **Specification**

a.	Size	72" width rolls
b.	Gauge	Double wall thickness 0.30 mm (+/- 0.02) - micro metre gauge
c.	Quality	Virgin Polythene (as base polymer)

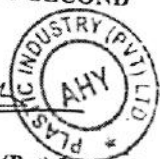
- 14.4 If a Force Majeure situation arises, the Firm shall, by written notice served on the first party, indicate such condition and the cause thereof. Unless otherwise directed by the first party in writing, the firm shall continue to perform under the supply order as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
15. **ARBITRATION:** - In case of any difference or dispute between the parties arising out this agreement or in the matter enumerated therein, the same shall be referred to the sole arbitration of the Managing Director PASSCO for the time being of Pakistan Agricultural Storage & Services Corporation Limited (PASSCO) or any person nominated by him whose award shall be final and binding on the parties to this agreement.
16. Terms & conditions of Tender Notice & Tender documents shall also be part of the agreement.
17. In witness whereof, the parties hereto have affixed their signatures on the agreement at Lahore on the date aforementioned.
18. Regarding the issue of jurisdiction in case of litigation between parties hereto the Court at Lahore shall have the exclusive jurisdiction to entertain such dispute.




