



#### 14. EVALUATION OF BIDS

- 14.1 A bid determined as non-responsive will be rejected and will not subsequently be made responsive by the bidder by correction of the non-conformity.
- 14.2 The relevant Committee will evaluate and compare only the bids previously determined to be responsive.
- 14.3 It will be examined in detail whether the services offered by the company complies with the Technical requirements as provided in this tender document. For this purpose, the company's data will be compared with the tender document eligibility and evaluation criteria along with visit to company facilities / offices for physical inspection at any time by the PASSCO Officers, if required.
- 14.4 It will be examined in detail whether the documents comply with the conditions of the tender document. It is expected that no major deviation / stipulation shall be taken by the company / firm.
- 14.5 Any minor informality or non-conformity or irregularity in the documents, which does not constitute a material deviation, may be waived by PASSCO (if deemed appropriate), provided such waiver does not prejudice or affect the relative ranking of any other company / firm.

- 15.1. No transportation contractor shall contact PASSCO on any matter relating to its tendering process from the time of opening to the time of tendering announcement.

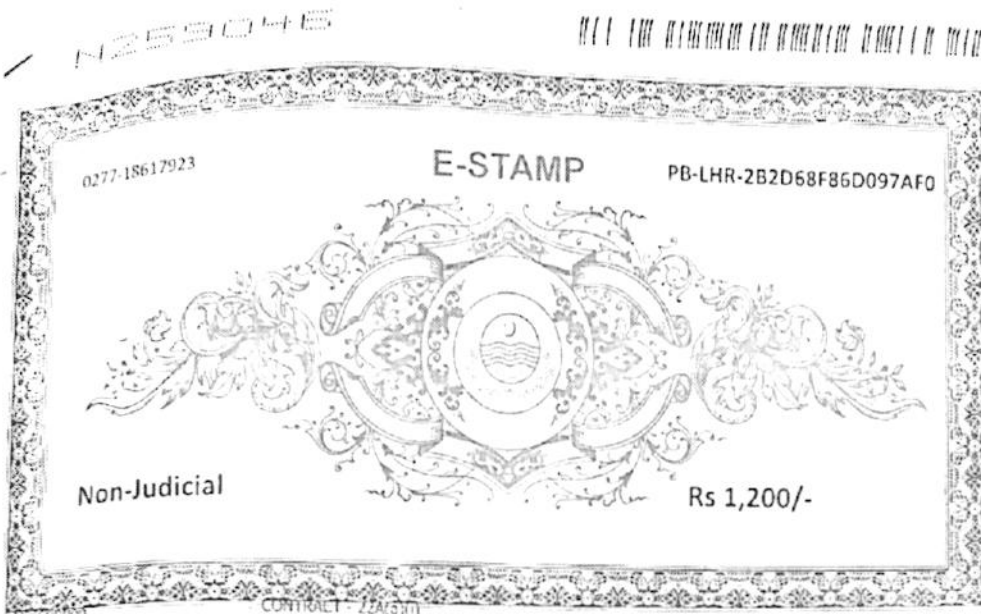

**AGREEMENT**

**PROVISION OF TRANSPORTATION SERVICES FOR SHIFTING OF 500,000 METRIC TONS IMPORTED WHEAT FROM PORTS TO PASSCO ZONES**

1. This agreement is made on 05-09-2022 between M/s Pakistan Agricultural Storage & Services Corporation Limited, (PASSCO) incorporated under the laws of Pakistan with office at 11 - Kashmir Road Lahore represented by it's General Manager (Commercial) hereinafter referred to as the 'Contractee' which terms wherever the context so permits includes its successors in interest of the first party.

AND

2. M/s National Logistics Cell (NLC), HQ, Transport Fleet (North), Gujranwala Cantt, represented by it's Senior Manager Marketing, North (NLC) hereinafter referred to as the 'Contractor' which terms wherever the context so permits includes its successors in interest of the second party regarding shifting of wheat from Karachi port Trust, Bin Qasim/FAP Marine terminal and Gwadar port to PASSCO Zones.

Contractee	Pakistan Agricultural Storage And Services Corporation Ltd, Head Office, 11-Kashmir Road, Lahore (PASSCO).
Contractor	National Logistics Cell (NLC), HQ, Transport Fleet (North), Gujranwala Cantt.

3. WHEREAS, this 2<sup>nd</sup> Party has agreed for provision of Transportation services regarding shifting of 500,000 Metric Tons wheat from Karachi Port Trust, Bin Qasim/FAP Marine terminal and Gwadar port to PASSCO Zones through dedicated vehicles, at the average contract value of Rs. 7,145,000,000/- (Rupees Seven Billion One Hundred Forty Five Million) vide acceptance letter No. PASSCO/ Comm/P-I/Import/2022/1643 Dated 18.08.2022 inclusive of all taxes, tolls, duties, loading and unloading, handling at the destinations or any other charges incurred in arranging safety measures (against weather, theft / pilferage / accidental loss, axle load condition and /or any damage etc.) during transit operation from dispatching to receiving ends. Quantity of wheat can be decreased, increased or altered as per instructions / decision when taken by Government of Punjab (P)/ PASSCO Authority, for which no claim or compensation and pecuniary gain shall be entertained nor entertained, allowed separately or inclusively in any case at all. However, the rate of transportation will remain same:-

4. Following shall be the responsibilities of both organizations.

A. RESPONSIBILITIES OF NLC:

- a) Comply with approved rates for shifting of entire quantity of 500,000 Metric Tons of Imported Wheat.
- b) Detail representatives at loading and unloading sites for completion of documents with PASSCO Staff, both at originating and destination ends.
- c) Provide transport and handling facilities, for lifting of (minimum) 6,000 Metric Tons to 6,500 Metric Tons of wheat per day per vessel including holidays from loading points end, failing which all consequential losses, (like demurrage for delaying of vessel / grounding/storage of wheat at port or TCP premises, cleaning and fumigation of TCP Godowns/premises, transportation to and from TCP Godowns / premises etc.) will be paid / borne by the contractor, if he fails to provide sufficient transport for the lifting of agreed quantity.
- d) Ensure dedicated truck marshaling area within 500 meters of designated loading points capable to carry sufficient trucks / Vehicle required for loading and transportation of minimum 6,000 Metric Tons to 6,500 Metric Tons per day per vessel.
- e) Ensure that all vehicles will be weighed on weigh bridges at either end, before and after loading / unloading. Contractor will pay for weighbridge charges at both ends. Preparation of proper documents and record regarding weighment of wheat at either ends will be the responsibility of contractor and PASSCO staff, at Karachi Port Trust, Bin Qasim/FAP Marine Terminal and Gwadar port and designated PASSCO Zones / locations (Geographical boundaries of PASSCO zones).
- f) Ensure adequate transportation for shifting of 500,000 Metric Tons Imported Wheat as per requirement at the ports.
- g) Ensure receipt of correct quantity, weight and quality of wheat stocks at loading points and deliver the same at PASSCO Zones/locations (Geographical boundaries of PASSCO zones) within Three (03) to five (05) days from the date of lifting from Karachi, Bin Qasim/FAP Marine Terminal/ storage point and ten (10) to twelve (12) working days from Gwadar port/storage point.
- h) In case of transportation from Gwadar, contractor may utilize warehousing at its own risk and cost.
- i) The contractor may also utilize trans- shipment at Hub/Karachi at its own risk and cost in case of transportation from Gwadar, however contractor must provide Convey Note and STN (Stock Transfer Note) generated at both Gwadar and Hub/Karachi.
- j) Pay all applicable taxes, duties, tolls, levies and port charges etc.
- k) Make payment to PASSCO against any loss to stocks during operations at following rate:-

1	Jute Bags	Rs. 417/-per Jute Bag	Plus 10% penalty charges E-STAMP
2	PP bags	Rs. 70/-per PP Bag	
3	Wheat	As per agreement with TCP + PASSCO's Expenses	

- l) Pay all charges labour engaged at loading/unloading points.
- m) Submit the bills along with all supporting documents to Commercial Wing PASSCO Head Office on weekly basis against transportation services. PASSCO will be make the payment of bills within Fifteen (15) days of the receipt of bills after written confirmation from Field Wing / S&C Wing or by operation team at Karachi Port.
- n) Ensure that the stocks are expeditiously moved/shifted and are not unnecessarily delayed at loading points, in transit or at destinations to avoid deterioration of wheat stocks including jute bags/PP bags.
- o) Deliver the stocks at given destination under his arrangements without any compensation for replacement of vehicle or diversion in case of road block or vehicle casualty.
- p) Apply after expiry of operational period of agreement/contract for the refund of security deposited after the last bill is paid by the contractee (PASSCO).
- q) Manage entire range of activities from lifting of wheat stocks till the stocks are unloaded at the destinations.
- r) In case of delay/detention of vehicle at Port due to fault on the part of TCP's stevedore, the transporter can lodge the claim upon PASSCO and the same shall be forwarded to TCP accordingly. The detention to be commenced after 24 hours of the arrival of truck at Port/warehouse. The claim shall be lodged with full documentary support with the counter signatures of TCP's officers/ surveyors. The maximum rate of delay/ detention shall be Rs.5,000.00/- per day per vehicle or pro rata basis.
- s) In case of non-fulfilling the daily lifting/ loading rate, demurrage charges as per agreement with importing agency (TCP) will be applicable.
- t) Transporter may maintain storage yard at its own risk and cost for local shifting of wheat in Gwadar/Karachi with necessary documentation like STN and transporter convoy note which will be verified from PASSCO representatives at both port of discharge and storage facility at the time of lifting of stock. Transporter will ensure maintaining same storage facility for currency of the contract.
- u) The fuel adjustment will be made in accordance with below mentioned mechanism having 50:50 ratio for fuel and non-fuel factors in rate per ton of each destination:-

**Increase or decrease in rate= Fuel factor x new fuel rate / agreed fuel rate**

In this regard the fuel rate for 15.08.2022 will be considered as agreed rate i.e RS. 244.95/- per liter.

**B. RESPONSIBILITIES OF PASSCO:**

- a) Establish offices and appoint sufficient managerial and supervising staff at loading points to coordinate with the contractor and different government offices for proper delivery of wheat stocks.
  - b) Get the acknowledgement on Dispatch Reports/Convoy Note from the contractor or his representative at the loading points about quality and quantity of wheat being dispatched.
  - c) Implement the terms and conditions of the contract in letter and spirit without failure. Any observation / complaint on the performance of the contractor/non-implementation / violation of the terms of the agreement shall be brought to the notice of designated officer of PASSCO.
5. Any claim on account of any vehicle being returned empty, fluctuation in transportation / fuel charges / rates, nationally and / or internationally, which may occur out of any cause, shall not be entertained.
6. If the contractor fails to discharge his contractual obligations and / or proves to be incapable of successfully completing the contractual obligations / non-implementation of any of the sub-clauses of clause 2, the same services will be carried out through any other agency or contractor at the entire risk and cost of the defaulting contractor, and the contractee (PASSCO) reserves the right to rescind the agreement, forfeit the security and impose penalties mentioned in the tender.
7. While submitting the bill, second party must indicate separately the amount of sales tax along with sales tax registration number issued by sale tax department.

8. PERFORMANCE GUARANTEE:

The second party has deposited 10% performance security amounting to Rs.927,100,000/- in shape of bank guarantee vide letter of guarantee No.IGT0840317122PK & NO.1858/55/2022 both dated 02.09.2022. The performance guarantee shall be refunded on successful completion of agreement / contract.

9. FORCE MAJEURE

- 9.1 Force majeure shall mean any event, act or other circumstances or considerations not being an event, act or circumstances under the control of PASSCO or of the Individual, Firm, Company i.e., Earthquake, Flood, or any other Severe Climatic circumstances and all events which are not under the control of the both parties like strikes, Dharna, Lockdown situation, etc. which are beyond the control of the parties. Non-availability of vehicles, laborers and other ancillary material/items or any other event leads towards clear negligence of the firm shall not constitute Force majeure.
- 9.2 If by reasons of Force Majeure, the required assignment / job / task cannot be performed by the due date, then the date may be extended appropriately by PASSCO on case to case basis keeping in view all the circumstances and requirements.
- 9.3 The firm shall not be liable for liquidated damages, forfeiture of its Performance Security, blacklisting for future tenders, termination for default, if and to the extent of his failure / delay in performance / discharge of obligations is the result of an event of Force Majeure.
- 9.4 If a Force Majeure situation arises, the contractor shall serve written notice on PASSCO, indicate such condition and the cause thereof. Unless otherwise directed by PASSCO in writing, the contractor shall continue to perform under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

10. Arbitration:



11. Jurisdiction of Court:

Regarding the issue of jurisdiction in case of litigation between parties hereto, the court at Lahore shall have the exclusive jurisdiction to entertain such dispute.



Without limiting the generality of the foregoing, we National Logistics Cell (NLC), represent and warrant that it has fully declared the brokerage, commission, fees etc paid or payable to any one and not given or agreed to give and shall not give or agree to give to anyone within or outside Pakistan either directly or indirectly through any natural or juridical person, including its affiliate, agent, associate, broker, consultant, director, promoter, shareholder, sponsor or subsidiary, any commission, gratification, bribe, finder's fee or kickback, whether described as consultation fee or otherwise with the object of obtaining or inducing the procurement of a contract, right, interest, privilege or other obligation or benefit in whatsoever form from GOP and / or PASSCO except that which has been expressly declared pursuant hereto.

03. We National Logistics Cell (NLC), certify that it has made and will make full disclosure of all agreements and arrangements with all persons in respect of or related to the transaction with GOP and / or PASSCO has not taken or will not take any action to circumvent the above declaration, representation of warranty.


04. We National Logistics Cell (NLC), accept full responsibility and strict liability for making any false declaration, not making full disclosure, misrepresenting facts or taking any action likely to defeat the purpose of this declaration, representation and warranty. It agrees that any contract, right, interest, privilege or other obligation or benefit obtained or procured as aforesaid shall, without prejudice to any other rights and remedies available to GOP and or PASSCO under any law, contract or other instrument, be void-able at the option of GOP and / or PASSCO and National Logistics Cell (NLC), declare that neither we have defaulted any contract / agreement with any organization / institution in last two years nor blacklisted by any one if, at later stage, this declaration has been found otherwise our security may be forfeited.

05. Notwithstanding any rights and remedies exercised by GOP and / or PASSCO in this regard, (the purchaser) agrees to indemnify GOP as well as PASSCO for any loss or damage incurred by it on account of its corrupt business practices and further pay compensation to GOP and / or PASSCO in an amount equivalent to ten times the sum of any commission, gratification, bribe, finder's fee or kickback given by (the Purchaser) as aforesaid for the purpose of obtaining or inducing the procurement of any contract, right, interest, privilege or other obligation or benefit in whatsoever form, from GOP and / or PASSCO. It is being clarified that PASSCO stands for Pakistan Agricultural Storage & Services Corporation Ltd, a company controlled / administered by GOP through ministry NFS&R Islamabad or any other entity owned or controlled by it (GOP).
