NEED ANALYSIS (Why the procurement was necessary?): The UCH Gas field is certified with ISO-14001 and OHSAS-18001 certification, it is under process of surveillance and Audit. As per Reg-341 oil & Gas (Safety in Drilling & Production) 1974 regulations of mines Act 1923, the functioning of Fire & Gas detection system is mandatory for Human & Plant safety. In this regard HSEQ team visited all areas of the field and highlighted observations regarding faulty/ non-operational detectors installed at different areas of Plant.

There are total 130 Nos. of H2S Gas Detectors installed on 15 nos. Well sites, gathering, separation, slug catcher, condensate storage and loading areas. Previously 30 detectors were replaced in 2018, now remaining 100 nos. old, faulty and obsoleted series detectors are required to be replaced with immediate effect to avoid major violation of above cited law, non-conformity and to achieve desired performance level for proper human and plant safety.
