NEED ANALYSIS (Why the procurement was necessary?): Dakhni Gas processing Plant is in operation since 1989 and 02 Nos. of Seismic Gas turbines of capacity 2.5 MW each are installed to fulfill its power requirements. These Turbines are coupled with 3410 KVA Generators to produce electricity.

Remaining in continuous operation round the clock, completing more than 200,000 running hours, C-type/ Major inspection of both the generators is due and required to be performed in order to enhance the efficiency and reliability of both the machines. Here it is noteworthy that the malfunctioning and breakdown of these generators can cause shutdown of plant resulting to production loss.
