(N-55) is a single carriage way road within the jurisdiction of maintenance unit Dadu. This N-55 section has an average carriageway width of 7.30 meters and about 2.50 meters width of shoulders on both sides. This highway plays an important role in the development of country and provides access to commuters and freight traffic between Karachi and up country. In Annual Maintenance Plan 2017-18, allocation was made for different sections of N-55, The above section is one of them. The approval for uplifting the section through periodic maintenance was forwarded to Member (South Zone) for initiation of procurement process.
