NEED ANALYSIS (Why the procurement was necessary?)	Khuzdar North JV has acquired approximately 473 L. Km 2D seismic data in the E.L and the same data set has been processed at OGDCL's in house processing facilities. Based on the resultant product after in house processing which is still underway, the data quality needs to be improved for delineation of the subsurface structural imaging. In further efforts to improve the quality of the data processing, two seismic lines have also been assigned to another independent team for processing at OGDCL's processing center. Keeping in view all these efforts, conventional processing did not contribute adequate improvement of the subsurface image to effectively delineate the subsurface horizons/ faults for proper mapping of the target structures.
