

- 3. The bidder has stated that regional Headquarter of Makita is in Singapore and all correspondence carried out from Singapore. Manufacturing unit is in China and country of origin is China. The same is acceptable.

Keeping in view of above deficiencies, their offer of Angle Grinder GA-9081 is vetted as non responsive.


