OGDCL as operator has made sizable discoveries of gas/ condensate in Togh-01 and Togh Bala-01 exploratory wells (Shekhan 3D area) in Kohat E.L from three stratigraphic units Lockhart, Lumshival and Hangu Formations. Kohat JVPs identified another prospect Sheen Dund in East of Togh structure and drilled well Sheen Dund-01 in Shekhan 3D area but unfortunately it was a failure and OGDCL encountered surprises (formation was deeper than actual and some faults were encountered which were not resolved in the existing processed seismic data). Furthermore, another lead has also been identified in Shekhan 3D but to firm up the lead into drillable prospect, Kohat JVPs recommended to reprocess Shekhan 3D along with Tanda Jabbi 3D Seismic Data.
