THIS AGREEMENT made on Friday, March 10, 2023 between Public Procurement Regulatory Authority of Pakistan (hereinafter called "the Procuring Agency") of the one part and M/S Piffers Security Services (PVT) Ltd., Islamabad, Pakistan (hereinafter called "the Service provider") of the other part:

 - (c) the Schedule of Requirements;
 - (d) the Technical Specifications;
 - (e) the Special Conditions of Contract;
 - (f) the General Conditions of the Contract;
 - (g) the Procuring Agency's Letter of Acceptance;
- In consideration of the payments to be made by the Procuring Agency to the Service provider as hereinafter mentioned, the Service provider hereby covenants with the Procuring Agency to provide the Security Services related services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Procuring Agency hereby covenants to pay the Service provider in consideration of the provision of Security Services and the remedying of defects therein, the

Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.

5. The Service Provider i.e. M/S Piffers Security Services (PVT) LTD, Islamabad shall be responsible to provide previous month's pay slip of the security guards clearly mentioning the amount of EOBI and Social Security charges deduction along with the invoice. Failing to provide, the same shall result in non-payment against the invoice submitted.
