OGDCL has 02 No. INOVA G3i seismic data acquisition systems procured in 2014-15. These seismic data acquisition systems are in continuous use since deployment (2015) in SP-2 & SP-4 in different areas of Pakistan to acquire seismic data.
OGDCL SP-2 has been assigned with Sajawal-South mega 3D project with 4032 3D active channels having total area of 765 Sq. Km. The indented items are required to use with G3i data acquisition system to meet the 3D operational requirement at SP-2, as current available quantity of G3i channels are insufficient to run the assigned project smoothly. These indented items will not only meet 3D operational requirement at SP-2 but will also be used for future 2D & 3D seismic data acquisition requirements.
