





UP-GRADATION OF OPS INFRASTRUCTURE (PHASE-II)
AT PAF CHANDER

1. Due to urgent military necessity and operational requirement the work for "Up-gradation of Ops infrastructure (Phase-II)" at PAF Chander is essentially required. If the work is processed through normal procedures for CWP, it would entail inordinate delay in the provision of essential facility, thereby causing adverse effects on operations of the FOB.
2. In view of the operational military necessity and urgency involved, I hereby invoke Para 17 of Defence Services Regulation for the MES 1998 and order the execution of "Up-gradation of Ops infrastructure (Phase-II)" at PAF Chander at an estimated cost of Rs 59.367 Mil (Rupees Fifty Nine Million Three Hundred Sixty Seven Thousand only).
3. The execution of the work shall be undertaken by AGE (Air) Risalewala to the accepted standard scales and to the cheapest possible specifications compatible with minimum essential requirements.
