

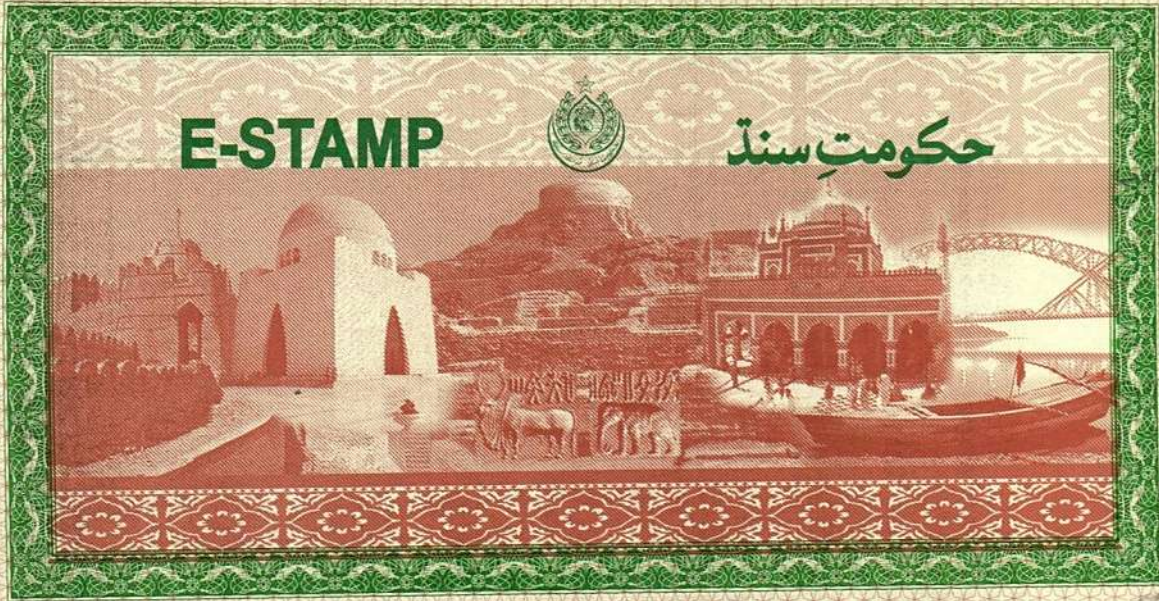

**ARTICLES OF AGREEMENT**

This Agreement made this 24<sup>th</sup> day of May, 2024, by and between the **Deputy Director (Procurement)**, Mehran University of Engineering and Technology, located at Jamshoro, Sindh, including his successors in office and Assignees / Agents, hereinafter called the "**University**", of the one part.

And **Mr. Zahid Hussain Dahri** of M/s **ZHD Engineers & Construction, Nawabshah**, located at **Kotri**, hereinafter called the "**Contractor**" which expression shall include their successors, legal representatives of the second part.

Whereas the **University** requires "Replacement of Main Water Supply Line at K.B Feeder to Railway Line Junction at MUET, Jamshoro **Replacement of Main Drainage Line of Old Boys Hostels i/c Manhole at MUET, Jamshoro**", and whereas the **Contractor** has agreed to execute the said work; valued at **Rs.9,857,786.00 (Nine Million Eight Hundred Fifty Seven Thousand Seven Hundred & Eighty Six Rupees Only)** in the period of **Three (03) Months**, subject to the terms and conditions set forth, hereinafter, which have been accepted by the **Contractor**.

Now this Agreement witnesses as follows:

1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in the **Conditions of Contract** hereinafter referred to.
2. The following documents which, for the purpose of identification, have been signed by **Mr. Zahid Hussain Dahri, CEO** on behalf of the **Contractor**, and by **Mr. Ahmed Rajpar, Executive Engineer (Development)** on behalf of the **University**, which shall be deemed to form and be read and construed as a part of this Agreement, viz.:






- a) Articles of Agreement;
- b) Instructions to Tenderers;
- c) Conditions of Contract;
- d) Contractor's Offer including the relevant correspondence prior to signing of this Agreement with all Annexures duly filled in;
- e) The specifications of the food items; and
- f) Bill of Quantity with prices.




