2. On 10 May 2022, PPRA promulgated Declaration of Beneficial Owners' Information of Public Procurement Contract Awarded Regulations, 2022 (The Regulations).

3. Regulation 4 of The Regulations reads as under: -

"Declaration of Beneficial Ownership Information: All procuring agencies while engaging in public procurement contracts worth Rs. 50 Million and above shall make a mandatory provision of beneficial ownership information of the company in the said contracts as per prescribed proforma (Annexure-I) in accordance with provisions of Forms-42, 43 and 44 of the Securities & Exchange Commission of Pakistan."

4. The definition of Beneficial Owner has been provided in Regulation 2 of The Regulations, which is reproduced below: -

"Beneficial Owner (BO)" means, — (i) natural person who ultimately owns or controls the bidder's company and / or the natural person on whose behalf a transaction is being conducted; or (ii) natural person who exercises ultimate effective control over a legal person or legal arrangement.

5. A conjunctive reading of Regulation 4 and the definition of Beneficial Owner manifests that such Regulations may not be applicable to M/s NLC for the reason that its ultimate ownership / control vests with the Federal Government which is not a natural person, rather is a legal person.

6. Forgoing in view, it is clarified that most of fields subject to personal information remain not applicable considering M/s NLC state being a public sector Organization. A copy of specimen (Annexure-I) dully signed is hereby shared with this letter for information / record and necessary action, please.

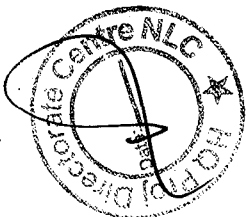
