

WHEREAS the Employer is desirous that certain Works, viz CONSTRUCTION OF MAIN CANAL AND DISTRIBUTION SYSTEM (EARTH WORK, STRUCTURES AND LINING OF MAIN CANAL & DISTRIBUTARIES) FROM RD 1252+000 TO RD 1286+000 UNDER CONTRACT KC-6B(3R) OF KACHHI CANAL PROJECT should be executed by the Contractor and has accepted a Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

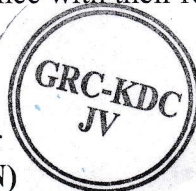
NOW this Agreement witnesseth as follows:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents after incorporating addenda, if any, except those parts relating to Instructions to Bidders shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (1) The Contract Agreement (if completed);
 - (2) The Letter of Acceptance;
 - (3) The completed Form of Bid;
 - (4) Special Stipulations (Appendix-A to Bid);
 - (5) The Particular Conditions of Contract – Part II;
 - (6) The General Conditions – Part I;
 - (7) The Specifications;
 - (8) The Drawings;
 - (9) The priced Bill of Quantities (Appendix-D to Bid); and
 - (10) The completed Appendices to Bid (B, C, E to L).
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




