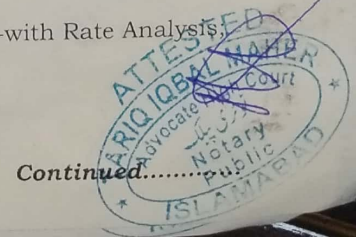
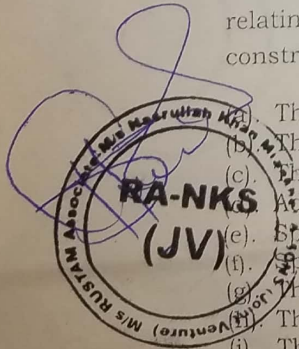
THIS CONTRACT AGREEMENT (hereinafter called the "Agreement") made on the 6th day of July, 2021 between **National Highway Authority, 28 Mauve Area, Sector-G-9/1, Islamabad.** (hereinafter called the "Employer" which expression shall include the successors, legal representatives and permitted assignees) of the one part and **M/s Rustum Associates - M/s Nasrullah Khan Main Khel & Sons (Joint Venture)** with office at **Al Badar House, Saad Abad, West Circular Road, Near Attock Petroleum, DI Khan.** (hereinafter called the "Contractor") of the other part.

WHEREAS bids have been received by the Employer for work "**Periodic Maintenance Work (Rehabilitation) between KM: 924+000 to KM: 927+000 on N-55 (DI Khan Qureshai Chowk to Muryali More), (AMP-2019-20), Contract No. RH-KPK-2019-20-02**" and bid of the Contractor for the said work amounting to "**Pakistani Rupees One Hundred Forty Five Million, Two Hundred Thirty Nine Thousand, Eight Hundred and Nineteen Only**" (Pak Rs. Rs. 145,239,819.00) has been accepted by the Employer vide letter No. **GM (P&CA)/NHA/RMA/AMP-2019-20/KPKRH-02/21/245** dated **April 19, 2021** for the execution and completion of such Works in all respects and the remedying of any defects therein.

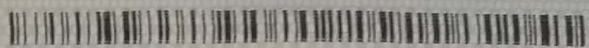
NOW this Agreement witnessed as follows:

3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. The work shall commence within Fourteen (14) days of issuance of Letter of Commencement and the Contractor shall fully complete the work within **178 Days**. The Defect Liability Period for the said work is **365 Days**.

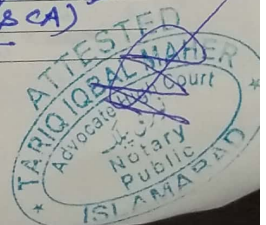

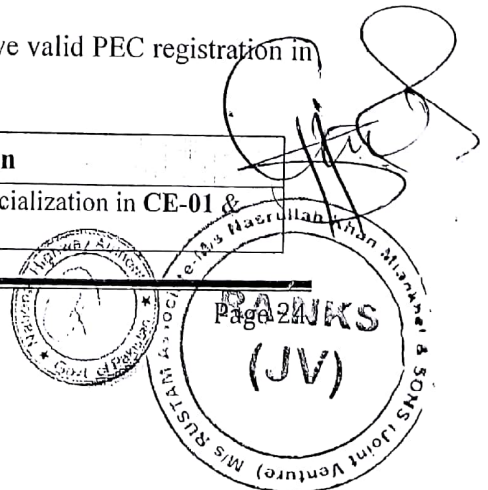

d. An individual bidder or JV meeting the above said conditions under Clause-3 (a), (b) & (c) will be considered for further evaluation and will be qualified if it meets the following Criteria:

i) Similar Work Experience:

Firm that has completed at least Two (02) Contracts (but not more than one Contract summed up for their values in this regard for each completed contracts) of similar size and complexity as a contractor or management contractor (but not as Sub-Contractor) with a minimum value of **Rs. 118.00 Million** each during last Five (05) years. In case of JV, if Lead Partner alone fulfils the condition, then the other partner is not required to fulfil the condition, otherwise each member shall be assessed according to its share in JV.

ii) Has an Average Annual Construction Turnover of minimum **Rs. 470.00 Million**. In case of JV each partner must fulfill the Criteria with respect to its share in the JV Agreement.

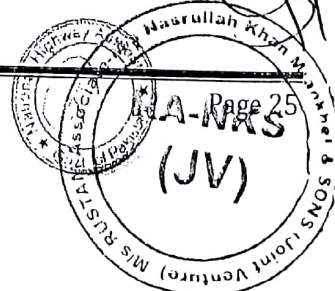
iv) Has a minimum Net Working Capital for the latest year of **Rs. 24.00 Million**. In case of JV each partner must fulfill the Criteria with respect to its share in the JV Agreement.

v) Past or present performance of the bidder as contractor (individual or all partners of a JV) is satisfactory with NHA or any other executing agency and the contractor has not been blacklisted earlier by any government agency / authority / organization.
