Financial Bids of only technically qualified bidders shall be opened and the Contract shall be awarded to the most advantageous bidder.

a) SBP BSC will review the information supplied by the bidders submitted for qualification and will make public the results of qualification to the bidders.

b) Firms/Companies applying for qualification are advised that any variation of constitution or membership from that put forward in response to this notice, without prior approval of SBP BSC may result in their disqualification.

The response to this notice must be sufficiently detailed to convince SBP BSC that the firms/companies applying for qualification have the experience as well as the technical, administration and financial qualifications necessary for the execution of the services and they must prove that they have carried out similar services in their own country or abroad.


