Lean Amine Air Cooler is critical to keep the lean amine temperature within the optimal range for efficient amine sweetening. Several tubes of air cooler were plugged temporarily due to frequent leakages, thereby decreasing the heat transfer area. This scenario may disturb amine process operations, leading to increased acid gas content in sale gas & consequent production loss. Therefore, installation of full length liners in the tube bundles of lean amine air cooler is required.
