- (b). On Completion. On completion of work the site shall be cleared by disposing of all rubbish, excavated spoil, etc. as directed by the Engineer-in-Charge without extra charges and the building shall be handed over fit for habitation/use in all respects.

8. The work timings shall be in accordance with PAF Base requirements.

9. Site plan may be seen in the Office of GE (Air) AHQ Peshawar.

#### 10. PAYMENT

- (a). Contractor's Percentage: The estimated cost at par with MES Schedule of Rates 2021 amended upto date for the work listed in Schedule 'A' is Rs 34,165,876/- and is valid for working out the contractor's percentage for purpose of pricing of deviations and/or amendments, provisional lumpsum & provisional items only

- (b). Payment of Schedule "A" items shall be made based on pricing of quantity of each item of the BQ according to progress achieved at the time of preparation of payment (RAR).
- (c). Contractor should be required to produce a certificate of clearance on professional and trade from excise an taxation department, otherwise the same will be deducted from his final bill against the subject CA.

- (d). The work carried out under deviations/amendments/provisional lump sum shall be measured in detail, entered in the Measurement Book, abstracted and priced on MES Schedule of Rates 2021 amended upto date subject to contractors percentage as defined above in this Para. Measurements shall be recorded as the work proceeds and shall not fall in arrears.
- (e). All items procured by the contractor for incorporation in the work must be supported with the invoices proving that necessary sales tax has been paid by the supplier at source.

- (f). Deduction of all type of taxes including income tax, Federal/Provincial sales tax and any other (Tax(s)) imposed by the Federal/Provincial/Local Government time to time will be effected according to law on the subject.

#### 11. SECURITY OF INFORMATION AND DOCUMENTS.

The contractor shall have to sign the security undertaking placed on Page \_\_\_\_\_ of the Contract Agreement.

#### 12. RECORD PLATE

- (a). A record plate will be installed on the building, by the contractor, at his own cost, to indicate the following:-

- (1) Name of Contractor, CA No.
  - (2) Name(s) of GE(s) with period.
  - (3) Name(s) of SDO(s) incharge with period (B&R and E&M).
  - (4) Names of Sub Engr B&R/ E&M Gde-II incharge with period.
  - (5) Dates of commencement and completion.
- (b). The record plate will be made in cement mortar 1:3, two feet above plinth level on a wall to be indicated by the Engineer-in-Charge. The writing will be engraved.
- (c). The record plate will be rectangular, of a size to be determined by the Engineer-in-Charge.

13. TIME & PROGRESS CHART. Work programme showing time and progress schedule of the project will be prepared by the Contractor and signed by the GE and CMES and submitted to the Office of Accepting Officer. This programme will be implemented upto the completion of the work and will be reviewed/updated after every three months to account for the changes, extensions and suspensions if any.

14. DRAWINGS: All working drawings are available in the office of CMES (PAF) Peshawar and GE (Air) AHQ Peshawar. Any contractor who wishes to any detail in connection with his bid may do so in the office of CMES (PAF) Peshawar and GE (Air) AHQ Peshawar.
