

The geophone groups are used in seismic field parties to acquire seismic data and are laid in field areas to pick seismic signals. These are frequently shifted from one place to another by vehicle or labor during acquisition and become damaged. These geophone strings are consumable in nature with useful operational life of 2 to 3 years. Since these are frequently damaged during seismic operations, seismic parties continuously demand geophone groups & spares to meet their field operational requirements.
