

#### TERMS AND CONDITIONS

1. SERVICES

#### 2. DELIVERY LOCATION &TIME

Once the bid has been accepted and approved by the PNSC Management, Successful Bidder shail deliver / supply and Installation of UPS at IBMS Server Room PNSC Building. Delivery of equipment's shall be made within Three (03) Weeks from the date of issuance of Work Order, which shall be considered as 100% supply. In case, bidder(s) delays the 100% supply or fails to execute the Purchase Order as indicated above, Penalty Clause No. 4, shall be applicable on them.

#### 3. WARRANTIES/MAINTENANCE/ SUPPORT/ SERVICES

- a) All equipment's/products will be inspected/tested and, if found faulty/damaged, shall be replaced by the bidder at the bidder's cost within Fifteen (15) days.
- b) Bidder shall provide the Principal Comprehensive warranty of all products / Equipment's / Accessories quoted in Tender Document from the date of delivery commissioning of the equipment.
- c) Bidder shall also provide onsite maintenance/support service for each category of products to be clearly stated in the quotations.
- d) Bidder and principal shall provide immediate technical support within 04 to 06 hours and provide backup of faulty accessories / equipment with same specification during warranty / maintenance / support period. Customer Support and maintenance office should be in Karachi.

#### 4. PENALTY / LIQUIDATED DAMAGES

- i. In the event of delay in supply of quoted product, PNSC will impose liquidated damages; bidder shall pay Liquidated Damages to PNSC at a rate of 0.01% per day of delay, subject to a maximum of Ten Percent (10%) of the contract amount. Also Contract may be cancelled and Performance Guarantee may be forfeited.
- ii. In case, bidder fails to execute the Purchase Order in full or in part as per delivery Clause, PNSC has the right to get the work executed from third party at the risk and cost of the bidder, as well as recover the amount of loss from its Performance Guarantee and/ or any payment due by PNSC to the bidder.

#### 5. ASSEMBLING

- i. Bidder shall be responsible for entire Installation and Commission on-site all supplied of UPS as mentioned in Bid Form and make it operational (Shall be completed within seven (07) days after 100% supply).
- ii. Bidder shall be responsible to provide Brochures / Technical documents / Installation Guides with documents and media (installation kit) and any other related documents of Products / Items / Software's.

#### 6. PAYMENT

#### 14. DISPUTE RESOLUTION

- a. This Contract shall be governed by the laws of the Islamic Republic of Pakistan and the courts at Karachi shall have exclusive jurisdiction.
- b. Any claims, demands, cause of action, controversies, dispute (s) in relation to any matter connected with or arising out of the Contract including any question regarding its existence, breach, validity or termination and not amicably settled between the parties themselves shall be referred to arbitration by appointing a Sole arbitrator mutually accepted to the parties hereto. or to two arbitrators, one each to be appointed by the two parties, and the said Arbitrators shall appoint an Umpire before entering upon the reference, and the award of such Sole Arbitrator or the two arbitrators or the Umpire, as the case may be, shall be final and bidding on both the parties. The arbitration shall be governed by the Arbitration Act 1940 as modified or re-enacted he venue of arbitration shall be at Karachi.

#### 15. EFFECTIVENESS

The Contract shall become effective upon execution by PNSC and Contractor.

#### 16. TERMINATION FOR DEFAULT

PNSC, without prejudice to any other remedy for breach of Contract, by giving one month written notice of default sent to the Contractor, may terminate this Contract in whole or in part:

- If the Contractor fails to complete the contracted works / Services, within the period/s allowed specified in the Contract or within any extension thereof granted by PNSC;
- If the Contractor fails to perform any other obligation/s under the Contract and/or violation/contravention of any other terms and conditions mentioned therein;
- c. If the Contractor assigns any of this service and/or in case of found corrupt or fraudulent practices in competing for or in executing the Contract.
- d. If the PNSC during the completion period of the Contract has reason to believe that Contractor will not be able to fulfill obligations under the contract.
