

#### **TERMS AND CONDITIONS**

#### 1. SERVICES

# 5. UNAVAILABILITY OF BOAT / OUT OF COMMISSION DUE TO DAMAGE

Contractor acknowledges and understands that in the event of unavailability of Launch Boat during the PNSC Hiring / required period, Contractor shall be liable to arrange the Launch boat for PNSC on the same agreed rates without any extra charges and make sure to provide contracted service without any delay.

#### 6. FUEL
