Bidders must submit their bids through E-Pak Acquisition & Disposal System (EPADS). Bid must be accompanied by scanned copy of Bid Security in the form of CDR/Pay Order, in the name of Divisional Accounts Officer, Pakistan Railways, Sukkur amounting as mentioned below, whereas, bid security in original shall be submitted in the office of Divisional Engineer-I (W.A. Section) alongwith other necessary documents as stated in bidding documents. Bids must be uploaded on EPADS before 12:00 hours on 21-11-2024.
- Only bids through EPADS will be entertained and no other bid will be accepted except EPADS, bids will be opened on same date and venue at 12:30 hours at COMMITTEE ROOM D.S. office, Sukkur in the presence of the representatives of the firms who want to witness.
