

Sealed tenders are invited as per Single Stage-Two envelope (SSTE) bidding procedure for leasing out of GEPCO owned P.C Pole Plant Chichoki Mallian District Sheikhpura initially for 03 (Three) years period (including one month maintenance period of each years) for Manufacturing & Supply of P.C.C Spun Hollow Poles including installation of additionally equipment / machinery required for manufacturing of HT / LT P.C.C Spun Hollow Poles at GEPCO owned P.C Pole Plant Chichoki Mallian District Sheikhpura from the bidders.

3. Installation of additional equipment / machinery required for running of Pole Plant to fabricate HT / LT P.C.C Spun Hollow Poles as per above quantities by the interested firm(s) will be made at their own cost. The firms interested are required to furnish their offer as detail below: -
 - i. Detailed and estimated cost of additional machinery / equipment to be installed by the firm at its own cost for complete setting up of P.C.C Spun Hollow Poles will be procured by the firms.
 - ii. Time schedule for installation of plant, machinery, equipment & prototype testing / approval will be 150-days after signing of contract agreement.
 - iii. Escalation / De-escalation clause will be applicable for 2nd and subsequent years.
 - iv. After completion of lease period or termination of contract by the fault of contractor before three-years, all machinery / equipment's installed by the firm will become the Property of GEPCO. However, firm can lift-up only moveable machinery at his own risk & cost i.e. moulds, welding plant, lathe machine, Boiler and Spun Machine.
