TERMS AND CONDITIONS FOR PRE-QUALIFICATION OF FIRMS FOR REPAIR OF MACHINERY AND EQUIPMENT FOR THE F.Y 2024-25

- i. The interested firms must have minimum 3 years' experience in relevant field.
- The firms should have their own complete setup i.e. machinery, spare parts availability and technical experts in Islamabad / Rawalpindi.
- iii. Telephone/fax facilities etc. in Islamabad.
- iv. The firms should be registered with Sales tax and Income Tax Department. (Valid documents may be attached).
- v. The interested parties must have sound financial position; proof may be provided.
- vi. Affidavit regarding Non-black listing of firm on stamp paper at least of Rs. 100/- value may be attached with bidding document.
- vii. The set up/firm, office and technical/professional competency may be assessed by physical visit of tender committee/members of the committee.
- viii. The repair/maintenance work of machinery and equipment will be awarded to the firms amongst the selected firms on fulfillment of pre-qualification criteria who quotes lowest rates on need basis.
- ix. The firms on the panel will be bound to carry out the requisite work on immediate basis when machinery and equipment is referred to it even at odd hours.
- x. While submitting rates, the bidders shall clearly show whether GST is excluded or included in the offered rates.
- xi. The firms will be bound to return old spare parts in case of replacement with new. Warranty period of each item replaced or repaired, should clearly be mentioned in quoted rates.
- xii. The bid validity period will be 30.06.2025.
