

## **TERMS & CONDITIONS:-**

- 1. Sealed tenders may be submitted at SP Office, District Hunza before closing time and date, which will be opened by the committee on the above mentioned date and time in presence of contractors/suppliers or their authorized representatives at SP Office District Hunza.
- 2. The contractor/supplier should have complete setup (own shop/workshop, technical experts/staff with vast and past experience along with documentary evidence.
- 3. The contractor/supplier must have his own complete setup (shop, workshop) containing adequate supplies in Gilgit as well as in Islamabad or authorized dealer/agent in Islamabad and will be bound to supply demanded items to SP Office Hunza.
- 4. The Bid security/Call Deposit Receipt 2% of total sanctioned budget in shape of Bank Draft/Pay Order of a bank in the name of SP District Hunza may be attached with the bidding/tender documents. Tender without Call Deposit Receipt from bank will not be accepted.
- 5. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
- 6. The rates of items if not covered in the "Prescribed Form" will be determined in accordance with the prevalent retail prices in the open market at the time of supply.
- 7. All kinds of taxes applicable (if any) will be inclusive in the bid price.
- 8. Conditional, ambiguous and incomplete tenders shall not be accepted.
- 9. The competent authority i.e committee reserves the right to accept or reject any one or all the tenders as per instructions/guidelines of PPRA Rule-33(1).
- 10. Firms quoting inappropriate rates other than market rates shall not be considered.
- 11. The contractor/supplier shall be bound to continue supply of goods/services/items in case of delay in cheque clearance or non-release of funds.
- 12. 02-years work experience documents/certificate in the relevant field, registration certificate and vendor number documents duly attested must be attached with the bid documents.
